RE: Colleen Condon Esq., 3 Gamecock Avenue, Charleston, S.C. 29407

I am hereby filing a complaint against Colleen Condon, an attorney practicing in Charleston S.C. . . . She was and is again my ex-wife's attorney who represented my ex-wife regarding the divorce action, my ex-wives' DSS case against her (past and current) and my ex-wives' CDV case in which she was a defendant. The period I am alleging miss-conduct for is from 09-15-2010 to present. The following is a list of my complaints, in which she used felons, her present position on the Charleston County Board, and other means at her disposal to violate the law and code of conduct. I have only decided now to file these charges because the abuse has not stopped and before now I did not want two of my children who are minors exposed to this. Also, I am a disabled veteran, and have had 22 Surgeries the last two and a half years at the VA hospital Charleston and MUSC. I have lost two ribs, my Pancreas, Gallbladder, Spleen, and 15cm of my small intestine. I am a type 1 diabetic now and have to take pills to digest my food. I am on 12 different medications and face more surgery in the future.

- 1.) On 25 September 2010 and then again on December 15th, 2010, she instructed her client (my ex-wife) via e-mail and text to break into my residence (which was not the marital home) and steal documents pertinent to their case. I have in my possession, intercepted texts and e-mails from Colleen Condon to my ex-wife telling her where, when and who was going to help her conduct the two burglaries at my residence 1712 Wappoo Dr., Charleston S.C. 29407. One burglary was worked by the City of Charleston police department, the other by the Charleston County Sheriff's office. My ex-wife has only admitted to the one investigated by Charleston County. I have these texts and e-mails because I was still paying her cell phone bill and the account was in my company's name, Peterson/Coastal communications.
- 2.) In an agreement to split attorney fees, Colleen Condon submitted to the court attorney fees related to her representation of my ex-wife in her CDV case in which Colleen Condon represented her. Colleen Condon admitted in court that it was an error, and told Judge Cate, a Charleston Family court judge that she would remove those charges. As of this date she has not removed those charges and fees.

She then directed my ex-wife to an attorney friend of hers and attempted to transfer the fees to his law firm. She has continued to harass me even calling me the day of my 2nd to last surgery in the ICU last January 2013, saying that she was going to have me put in jail if I did not pay those fees. That is extortion. This conversation was recorded, witnessed by my present wife, who is an ICU nurse at Roper hospital in Charleston, and a VA ICU nurse. She even showed up at MUSC this past June, 2013 to further harass my concerning those bogus charges and during my last surgery June 18, 2013.

- 3.) She was having a lesbian affair with my ex-wife, in 2010, which resulted in her (Colleen Condon) own divorce. It was reported in the Post and Courier newspaper, but the paper left out my ex-wives name for reasons unknown to me. I later found out that my ex-wife did not pay a dime in attorney fees; however Colleen Condon fabricated fees to submit to Charleston County family court.
- 4.) She continuously sent e-mails and voice messages threatening to use her influence being a council woman on the Charleston County Board by saying everything from having my business license revoked to revoking my license to work from home in Charleston County from the zoning board. I am no longer in business but receive Social Security and retirement from my 22 years as active duty Air Force and Army.
- 5.) Colleen Condon and my ex-wife Jill Peterson enlisted the help from a current City of Charleston police officer to keep tabs on me and call in tag numbers of any vehicle at my residence and harass me everyday. The officer did this while on duty. One of the Tags that was run is what led to my ex-wife finding me one day and my wife was arrested for CDV for the attack. I have enclosed the letter from City of Charleston police department confirming this. My ex-wife told me Colleen was paying this officer to do this.
- 6.) Colleen Condon had my ex-wife bring what I did not know was a divorce agreement to me while I was in the ICU at the VA hospital Charleston. I was tricked into signing this while semi-conscious.

In closing, I have only "touched on" a few major issues, for which I have documented evidence. I recently took my ex-wife back to court over monies owed to me by her and Colleen Condon is representing her again, lodging the same threats very arrogantly. I ask the board for an investigation into these allegations.
