what happened. \_\_\_\_\_ stated that williams was there that the guy who took his money was with williams. I called williams over to talk with him and he stated that he had seen the robbery take place, but that he didn't know the individual who was with him and he had nothing to do with the incident. while I was standing with williams and \_\_\_\_\_ provided me with a description of the suspect and said that he was around 19-21 years old, had on a black jacket, and black and red shoes. \_\_\_\_\_ stated to me that williams and the other individual had been together during the incident.

After Ofc. Callison was on scene I pulled \_\_\_\_\_ to the side and spoke with him again about what happened to get a better understanding. \_\_\_\_\_ stated to me verbally that he had been walking by the barber shop, which I knew to be on Dime St, when he had been approached by 2 males, one of whom had stolen \$10 from him and wouldn't give it back. \_\_\_\_\_ stated repeatedly that they "took my money". He stated that the male who took the money ran off, and he followed the other male, identified as Izeal williams, to 515 Webster Rd while he called the police. He stated to me after telling me that williams was not involved, that "the boys took my money." I asked which boys, and he pointed to williams. I asked him why he was telling me williams was involved and he said it was because the two boys were together. He stated to me that he could tell the two boys knew each other.

I spoke with williams again. He stated that he had seen the incident occur. He stated that he was walking along the road and the suspect, whom he stated he did not know, was walking with him but not really "with" him. He offered a brief description of the suspect that matched what \_\_\_\_\_ had stated to me, saying he was around 19, had a black hoodie, and a beard, but stated that he did not know who he was and did not recognize him. He said he did not know the suspect's name or any other identifying information and had never seen him before. williams did provide a written statement to Ofc. Callison regarding the incident. williams statement to OFC Callison is as follows:

"I walked an a man asked for crack a guy with a black hoodie came by and took the money and left by an old barber shop. I don't know either of them. I was walking and the guy ran past an I never seen him after." END OF STATEMENT

\_\_\_\_\_ then stated to me that during the incident, a woman had yelled off her porch to the suspect that he should give the money back or she was going to tell his mother. I then asked \_\_\_\_\_ to show me the location where he saw the woman, as I intended to ask her who the suspect's mother was. I put \_\_\_\_\_ in my car and started to drive up Clark St. As I

<b>NARRATIVE</b>	<p>passed Webster Rd, I saw a black male wearing a black jacket. khaki colored pants and black and red shoes walking up Clark St towards 515 Webster Rd. _____ started yelling from the back seat of my car "That's him, that's him!" I stopped my patrol vehicle and other units quickly came to the area where they detained the suspect. I recognized the suspect as Deontea Mackey due to previous contacts with him in this area.</p> <p>I spoke with _____ again and he stated that he was certain that was the suspect who had taken his money. He stated to me at that time that he had been walking around the area looking for something for sale. I asked him if he was looking for crack and he stated that he was. He then stated that the suspect took \$10 from him after he approached him.</p> <p>After reading Mackey his Miranda warning from a standard card, I told Mackey that he had been detained because he had been accused of robbing a man up the street. Mackey became angry and yelled and cursed and stated that he didn't do anything. I then told Mackey that I had heard that the man had offered Mackey money in exchange for crack. Mackey stated that the man had approached him and asked him for crack, he told him yes, and he handed him a \$10 bill. Mackey stated that he took the money and then walked away from the man. He stated that he wasn't going to give them man his money back because the man had given it to him. He stated that the \$10 was still in his jacket pocket that the man had given him. I asked Mackey how he knew Williams and he stated that Williams was his "homeboy", meaning that they were good friends.</p> <p>While speaking with Mackey, Ofc. Smith had obtained a written statement from _____ about the incident. After reading the statement, I discovered that it differed from his original verbal account to me about the robbery. The statement recorded by Ofc. Smith from _____ is as follows:</p> <p>"I was walking near the barber shop at Dime Street and Chaney Street looking for crack. Two guys were walking near the barber shop also. One was a black male wearing a black jacket, brown pants, and his hair was in short braids. The other was wearing brown pants and brown hooded jacket and his hair was in long weaved braids. He was black male also. The black male with the short hair, black jacket, approached me and said "Hey man, whatcha need?" I said "I need a 10". The guy then said "I got your 10." I then handed him a 10 dollar bill and he took it and started to walk off. I then said "Come on man give my money back!" The guy with short braids then said "This is my money now, I ain't giving it back. I'll shoot you!" I then asked him several times to give my money back and he wouldn't. with longer braids tried to tell the guy who took my money to give it back. Then they left. I called the police. This statement was written for me by A. Smith \*677. It is true and accurate." END OF STATEMENT

After reading the victim's statement, I saw that although \_\_\_\_\_ had stated to me several times initially that Williams had been involved in the robbery, in his statement he stated that Williams tried to stop Mackey. He did not make any verbal statements to me that Williams tried to stop Mackey after Mackey had taken his money. Williams, too, did not mention at any time that he attempted to stop Mackey from taking the victim's money.

After gathering the information from this case, Deontea Mackey was charged with Armed Robbery due to the victim's statement that Mackey had threatened to shoot him after taking his money. Mackey was charged as an adult with a class A felony. Williams was charged with Interfering after it was discovered that he and Mackey were "homeboys" and that he appeared to be deliberately concealing Mackey's identity during the investigation. Williams was transported to the detective division after he indicated that he wanted to speak with a detective. He was issued his citation in the detective division, told his court date and time, and consequences if he failed to appear, and then was driven home after his interview. Mackey was transported to the Greenville County Juvenile Detention facility. I obtained warrant 2015A2320600587 from ministerial recorder Heaton, charging Mackey with Armed Robbery. Ofc. Jacobs served Mackey with his warrant in the juvenile detention facility. \_\_\_\_\_ was provided with a copy of his victim notification form. Ofc. Jacobs completed a property and evidence sheet returning the \$10 to \_\_\_\_\_ from Mackey's possession after Mackey stated that the \$10 bill in his pocket was the money he had gotten from \_\_\_\_\_. During the investigation my body camera was activated. The video will be downloaded to the video server.

Mackey's mother was notified by Ofc. L. Paramore and she provided a contact number to reach her: \_\_\_\_\_ Sgt. Lawson notified me that Family Court had set a hearing for Mackey for 3/9/2015 at 1000. A copy of the violent crime bond checklist was emailed to the violent crime bond checklist email group and sent to the ministerial recorder for review.

This case is cleared by arrest.

were double-locked and checked for fit) until the on-scene investigation could be completed. I subsequently placed him into OFC Paramore's patrol car since it was closest to my present location. I later moved Mackey to my patrol vehicle so that I could transport him to the juvenile detention center.

Prior to transporting Mackey I was informed that Mackey had stated to OFC Lentz that the victim's stolen \$10.00 was in his coat pocket. I subsequently retrieved the \$10.00 from Mackey's left inner coat pocket. I did complete a property and evidence form that signed in order to document the transfer of the \$10 bill back into his custody. The serial number for the \$10 bill is JE03459008 B.

At this time I transported Mackey to the juvenile detention center. I transferred custody of Mackey to the correctional officer on a temporary commitment form while OFC Lentz obtained the listed warrant on Mackey for Armed Robbery. Once OFC Lentz had obtained the warrant, I returned to the Juvenile Detention Center where I signed and served the warrant on Mackey.

While I was filling out the Pre-Detention checklist in the juvenile detention center, I asked Mackey if he belonged to any street gangs. Mackey replied that he did. I asked him which gang he was a member of, and he quickly replied, "blood in blood out" to inform me that he was indeed a blood affiliated gang member.

I was wearing my body camera, and I recorded my interaction with Mackey while I was engaged in the Armed Robbery investigation.

**Narrative:**  
I responded in the area of Webster Rd to assist in looking for robbery suspects. While en route Ofc. Hutton who had made contact with the victim advised one of the suspects was wearing a black jacket or hoodie and red shoes. Dispatch also advised he was wearing tan pants. While traveling behind Ofc. Hutton down Clark Street from Webster Road I observed a male fitting that description walking down Clark Street towards Webster Road. Ofc. Hutton while transporting the victim passed the suspect she immediately stopped and stated this was possibly the suspect. I stopped in front of the suspect and advised him to stop for a moment while I talk with him. I patted him down for weapons and then began questioning him about his whereabouts earlier.

He stated he had been at his grandma's house and was seemed nervous when questioned. I also asked him if he had been alone and he stated he had been with his "homeboy" but stated he would not tell me his name. He stated he did not want him to go "down for anything". He stated multiple times he was not going to tell me his name. He asked multiple times why he was stopped and he was advised he fit the description of a suspect in a possible robbery. Ofc. A. Jacobs was currently talking with Hutton and then advised the subject was confirmed to be our suspect and placed handcuffs on him. Ofc. Jacobs advised he was being detained and he immediately became irate and began yelling that he could not go to jail. He was placed in the back of my vehicle temporarily while Ofc. Hutton mirandized him and questioned him further.

After the field investigation was completed Ofc. Jacobs took the suspect in his custody and transported. I then cleared the scene.

The male with short braids then took the ten dollar bill and began to walk away. \_\_\_\_\_ stated he then told the guy to give his money back when he realized he didn't have any drugs. \_\_\_\_\_ stated the male with short braids said "this is my money now, I'll shoot you!" \_\_\_\_\_ asked several more times to give the money back and thought about forcefully taking it back but thought he better not in case the suspect really does have a weapon, even though the suspect did not display one.

**Narrative:**  
On the afternoon of 3/5/15, I responded to the area of Clark Street and Webster Street in reference to a robbery just occurred. Dispatch advised that the Subject was a black male in brown pants and a white shirt. Officer Lentz was in the area as well and advised me that she was out with a group and she was behind the 400 building at 515 Webster Rd. I made contact with Lentz and she pointed to Izeal Williams, who I know from previous contacts, and she stated that the Victim, who she was present with, had identified Izeal as being with the Subject when he was robbed. I made contact with Izeal and asked him what he knew about the robbery.

Izeal gave me a written statement telling of how while he was walking down Dime Street near Dime Court, he heard a person ask for crack and when he turned around to look, he observed the Victim in this case to be holding money out and a black male in a hoodie grab the money and run off. He told me that the male that took the money was about nineteen years old and he had never seen him before.

I passed this information on to Officer Lentz and she at this time was giving the Victim a ride back to the location where the crime occurred. A few moments later, Lentz advised dispatch that she was out with the Subject of the case and shortly later advised me that Izeal needed to be arrested because he was involved with the robbery and I did then transport him to her at Clark and Webster.
