I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

On January 24, 2018, Timothy Wayne Gibson did willfully and unlawfully violate SC Code of Laws 16-3-29, Attempted Murder, by driving a vehicle toward and hitting the victim Brian Wingard, with the vehicle. By striking Wingard with the vehicle, Gibson did attempt to murder Wingard. Wingard rolled over the vehicle and injured his knee. The incident occurred near the intersection of Victor Hill Road and Hwy 80 on the power line access road, within the city limits of Greer, SC in Spartanburg County. Probable cause was based on law enforcement investigation, witness and victim statement and video. TCM
