

On 04/19/2020, I responded to 601 Tayser Ct in reference to a shooting incident. Upon arrival I spoke to Joshua Fogelman who stated that his friend Evan Phillips and Paxton Stone were drinking and playing with poker with their neighbor James O Connor when James decided to leave the table and walk out the back door with a poker set and a wallet. Joshua stated that Evans wallet went missing. Joshua stated that he and Evan went over to James House to grab the poker set that James took and ask James if he took Evans wallet. Joshua stated that James denied taking the wallet and that the poker set was on James Counter. Joshua and Evan then took the poker set and walked outside. Joshua stated that James started following them outside and got angry at Joshua and Evan and started to threaten them that he would go back into his residence to grab his gun. Joshua stated that James ran back inside the house and walked back outside with a gun and shot one round up in the air. Joshua stated that he and Evan ran back into the residence and Joshua was looking through the glass window and noticed James pointing a gun directly at him and James fired a shot directly at him. Joshua stated that James came to the door of the residence and started making loud noises and banging on the door and being very loud and boisterous. Joshua stated that James ran back into his residence and then the sheriff department showed up. Joshua, Evan, and Paxton all provided a written statement on the incident that occurred. The case was taken over by Sgt. Creech.
