Section Title: Reason for Separation

Type description of the alleged misconduct::

On September 1, 2021 a female complainant came into the City of North Charleston Police Department to file a complaint against NCPD Officer Darryl Felkel. The complainant who was with her mother advised that Felkel, while working off-duty security, in uniform made unwanted sexual advances while at her place of employment. The complainant advised while working in the shoe department of a local department store Felkel approached her and propositioned her for sex. The complainant advised that they had been cordial in the past, but conversations never involved sex. Felkel initially wanted sex, when denied he asked for oral sex, then for just a "make out session". The complainant began discreetly recording on her cell phone the remaining part of the conversation which lasted approximately 8 minutes. Felkel is heard on the recording trying to coerce the complainant into performing a sexual act that wouldn't last more than 10 minutes. The complainant is clearly not interested and tells Felkel "no". The complainant tells investigators that she told him that she had to get something for work and walks away. She immediately tells her store manager what happened. The complainant provided investigators the audio recording and a written statement. Investigators interviewed Felkel who initially told investigators that there was no inappropriate conversation. He changed his account of the conversation several times. He provided a signed written statement. Investigators then brought Felkel back into the interview room and confronted him with the fact there was an audio recording of the conversation. Felkel changed his account once again, and stated that maybe it was an inappropriate conversation, but he never asked for sex. It was stressed that lying would be deemed grounds for termination. He was also advised that lying could affect his State Certification. He was given every reasonable consideration to provide investigators with the facts of the incident which he failed to do. When Felkel was asked if he wished to hear the recording in its entirety he
