Personally appeared before me the affiant Akil A Crosby who being duly sworn deposes and says that defendant Charles Michael Long, Jr did within this county and state on or about 6/2/2022 violate the criminal laws of the State of South Carolina (or ordinance of [X] County/ [] Municipality of) in the following particulars:

DESCRIPTION OF OFFENSE: Domestic / Domestic Violence, 2nd degree

I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

On June 2, 2022, Charles M. Long, Jr. and the victim were engaged in a heated verbal altercation outside the above-mentioned location. Charles M. Long, Jr. proceeded to enter the personal space of the victim without permission. Once in the victim's personal space, Charles M. Long, Jr. used his left foot and kicked the victim's right hip causing phone to fall to the ground. Charles M. Long, Jr. then attempted to prevent the victim from having use of phone by kicking it with his right foot. The victim prevented Charles M. Long, Jr. from kicking the phone by pushing him with two hands. The offence was committed in its entirety in the presence of a twelve-year-old juvenile.
