Narrative:

I received the results of the CHIME bank account search warrants. There was no activity from Pogue on the card. There was a direct deposit from Ingles Market for \$16.61. This was deposited of July 6, 2020.

NARRATIVE
On 07/14/2020 I met with Wyatt [REDACTED], Debbie [REDACTED], and Nathon Brown. Nathon is good friends with Casi. Wyatt and Debbie Brown are Nathon's parents. They also own the home that Casi was living in on Reid School Rd. The Brown's live in a house behind Casi's and on the same property. Nathon's address is [REDACTED] Lewis Dr. Apt. [REDACTED].

Watt gave me access to Casi's house so I went inside and looked around for any evidence or indication of where she might be or what happened to her.

While speaking with the Brown family I learned that on July 4th Casi unluckily entered a house across the street from hers. The homeowner confronted her and walked her over to the Brown's house. Casi appeared to be hallucinating and talking with imaginary people so Debbie Brown drove her to Prisma Health-Greer campus. Casi was released 4hrs later.

On the morning of the 5th, the resident from across the street observed Casi jump out of her bedroom window. She fell to the ground and then walked into the woods behind her house. The neighbor notified Wyatt and Debbie of what he witnessed.

After a search for Casi, she was located in the woods behind her house. She was bleeding and bruised. 911 was called and both the Greenville Co Sheriff's Office and EMS responded.

According to Katrina, she talked with "Christine" and "Christine" was able to confirm through identifying tattoos that the girl she saw was in fact Casi. According to "Christine" she did not know the girl was a missing person. She asked the girl what she was doing in the shed and the girl told "Christine" that she was waiting on her boyfriend to show up. The girl then left the shed. After she left, "Christine" saw that she left a pack of cigarettes behind. The cigarette brand was Camel crush.

I was provided a phone number for "Christine" of ██████████. I called her to follow-up with her but she and I played phone tag with each other for a couple days.

On 12/04/2020 I called "Christine" again. She agreed to meet me at her house and she would talk with me about this case. I drove to Christine's home located at █ Ashridge Way Simpsonville, SC 29681.

"Christine" was fully identified as Christine Boishe. She explained to me that there is a

During my interview with Christine Boishe on 12/04/2020 she also explained to me who another lady who lives in the same subdivision told her that she saw a person she believed to be Casi at their community pool a couple of days after Christine saw her in the shed. This lady told Christine that the girl she believed to be Casi was with a heavy set white female who had black hair and was covered in tattoos.

Christine also told me that Casi had been seen inside the open garage at [REDACTED] Avenel Ct which is within this same neighborhood.

I began researching the residents that live at [REDACTED] Avenel Ct. I found that the female who lives there is named Crystal Drippers. Photos of Crystal Drippers on her Facebook page show that Drippers has a similar hair style as Casi. Drippers is also similar in stature to Casi.

On 12/8/2020 I drove to [REDACTED] Avenel Ct and made contact with Drippers. I explained to her why I was there. When I told her that I was investigating a missing person and that I had information that the missing person may have been seen in and around her neighborhood she seemed to know what I was talking about.

Drippers told me that she was contacted by Katrina Bruns via Facebook and asked about Casi. Drippers stated that she did not know Casi and had never seen Casi other than pictures of her on the missing person flyer.

Drippers confirmed that it was her and her friend that was seen at the pool and not Casi. It is believed that Drippers was mistaken as Casi because of their similar features.

She also began acting very erratically including jumping out of a window of her home, unlawfully entering her neighbor's home, and running into the woods where she was found by friends bloody and bruised. Because of her condition, Pogue was transported to a local hospital for treatment. On 07/05/2020 Pogue is captured on video surveillance walking away from the hospital and towards a wooded area. Pogue suffers from mental health complications and is considered missing endangered person. Efforts to locate Pogue have been unsuccessful so far. It is this affiant's belief that Pogue's Chime account may assist investigators locate Pogue.

My name is Russell Irvin. I am a Sergeant with the Greenville, SC Police Department. I have been a police officer for 20 years. I am currently assigned to the investigations division. I am authorized by state law to conduct searches and seizures.

On 07/05/2020 a female by the name of Casi Ann Pogue, date of birth [REDACTED] was reported missing by her family. The investigation showed that in the days preceding Pogue's disappearance she began experiencing hallucinations. She also began acting erratically. She unlawfully entered her neighbors home and began removing things from the kitchen, jumping out of her bedroom window, and running into the woods where she was found bloodied and bruised.

Because of her condition, Pogue was transported to a local hospital for treatment on 07/05/2020. Pogue was discharged from the hospital later the same day. Hospital video shows Pogue walking away from the hospital on foot. Her family has not seen or heard from Pogue since then.

Pogue suffers from mental health issues and is considered a missing endangered person. Efforts to locate Pogue have been unsuccessful.

It is this affiant's belief that medical records held by Prisma Health documenting Pogue's injuries and treatment may assist this affiant with this investigation.

My name is Russell Irvin. I am a Sergeant with the Greenville, SC Police Department. I have been a police officer for 20 years and I am currently assigned to the investigations division of the GPD. I am authorized by state law to conduct searches and seizures.

On 07/05/2020 a female named Casi Ann Pogue, date of birth [REDACTED], was reported missing by her family. The investigation showed that in the days preceding Pogue's disappearance she began suffering from hallucinations. She also began acting very erratically including jumping out of a window of her home, unlawfully entering her neighbor's home, and running into the woods where she was found by friends bloody and bruised.

Because of her condition, Pogue was transported to a local hospital for treatment. On 07/05/2020 Pogue is captured on video surveillance walking away from the hospital and towards a wooded area. Pogue suffers from mental health complications and is considered a missing endangered person. Efforts to locate Pogue have been unsuccessful so far.

Pogue's friend, N.S., told me that Pogue left her phone at her residence when she was transported to the hospital but they were unable to locate it. However, Pogue's mother states she received a text from Pogue's phone while Pogue was in the hospital. Pogue's father also states that he received a call from Pogue on Pogue's phone. During the call Pogue stated "I've got to go, the nurse is coming in". This was on July 5th while Pogue was in the hospital. Pogue's phone was later turned over to me by N.S. N.S. admitted to me that he had the phone from the time Pogue went to the hospital but was afraid to turn it over to me because there are pictures/videos on the phone that depict him using drugs. It is this affiant's belief that information held by Sprint concerning cellular phone number [REDACTED] will assist with locating Pogue.

On December 9th 2021 I received the data from Pinterest I had requested via a search warrant. The data was 7,875 pages long. The majority of the data consisted of IP address with no date or time associated with the IP address.

NARRATIVE

On Jan 10, 2022 I spoke with Katrina Burns. She provided me with contact information for a Fred Woodard [REDACTED]). He is a private investigator with Woodard Private Investigations Firm out of Pittsburgh, PA. Katrina told me that he was helping in the search for Casi and asked that I call him and share any potential information with him.

I called and spoke with Woodard on Jan 11th or 12th. Woodard explained to me that his office had been contacted by a non-profit organization and asked to take a look at this case. Woodard explained that he did not think there was much his office could do. I shared with him a brief overview of the case and what I had done up to this point. He did not have anything to add and invited me to call him back if I thought there was anything he could do to help.

On Friday Jan 14 I was contacted by Matthew Daniel. He is an ex-husband of Casi's and is the father of Casi's daughter. I confirmed this with Katrina. Daniel explained that he owned a security company (Stonewall Security [REDACTED])) and offered to assist with this case anyway he could.

On Jan 20th I received an email from Matthew Daniel. He asked if anyone had looked into Jeffery Ei. He said that Jeffery was also an ex-husband of Casi's and had a history of stalking her. According to Daniel, Ei was living in Simpsonville ([REDACTED] Granary Dr) at the

According to Daniel, Ei showed up at Casi's house (████ Granary Dr) and retrieved some of his belongings. (Casi was either moving out or being evicted from that house).

After researching Ei through CLEAR, it appears that he currently lives in Kansas. A potential phone number for him is ██████████.

During my conversations with Katrina, she has told me about a guy named Brandon McCoy, who she said was Nathan Brown's ex-boyfriend during the time that Nathan and Casi were friends.

I was able to identify McCoy as Robert Brandon McCoy ██████████. It appears that he is currently living in Myrtle Beach, SC. I will try to contact via telephone for an interview.

On Jan 25 I located Jonathon Lackey. He was friends with Casi in the months before she disappeared and would spend time with her at her house in Taylors. I drove to Lackey's residence and spoke with him █████ Miller Rd. Apt. █████ Mauldin, SC █████

Lackey explained to me that he met Casi while they were both at Marshal Pickens in March or April of 2020. They became friends and continued to hang out together after they were both released from the hospital. He said that the last time he saw Casi was on June 21, 2020 when he had a cookout at his old house (████ Elm St Mauldin). He said that Casi was there with Nathan.

Lackey said that other than drinking and marijuana use, he did not know Casi to use hard drugs. He said that was the same for Nathan. He never saw Nathan using hard drugs. However, he admitted that he did not know Nathan that well. He knew Nathan and Casi were best friends and were always together. He also denied ever going to Nathan's condo on Lewis Drive and did not know where it was. He also said that he did not know anything about what might have happened to her.

On the same day, I interviewed Thomas Derek Davis (████ SCDL █████) at his residence at █████ Willowtree Dr in Simpsonville. I had identified Davis as being a boyfriend of Lackey's in 2020.
