Offenses:  
ANIMAL CALL

On 12/17/2022 Sergeant Richey and Sergeant Willard responded to [REDACTED] in the city limits of Laurens in reference to an animal complaint about dogs in the complainant's yard. Dispatch informed me that if I saw the dogs in question to "shoot" them on sight per Animal Control. Upon arrival, I made contact with the complainant [REDACTED]. Complainant advised that there were three dogs in her back yard that had been pulling on a dead goat carcass and she was scared to go outside. [REDACTED] stated that she did not see the dogs kill the goat because it happened sometime Thursday on 12/15/2022. As I walked around the residence I saw a beige in color dog that had a collar around his neck along with two other dogs. At this time I advised dispatch that the dogs were still in her back yard.

While waiting on Animal Control from Laurens County Sheriff's Office to arrive on scene, all three dogs were laying on the ground in the back yard. When Laurens County Sheriff's Office along with Animal Control arrived on scene, Lieutenant Byrd and Sergeant Geoff Brown exited their vehicles without making contact with myself or Sergeant Willard. Lieutenant Byrd had his shotgun in his possession. When both Laurens County Deputies approached the dogs, all three were still laying on the ground. Lieutenant Byrd took aim and shot the larger beige collared dog with his shotgun. All three dogs at this time took off running in different directions. The injured collared dog limped away into the woodline yelping. Neither Lieutenant Byrd nor Sergeant Brown made contact with the complainant while I was on scene.
