He stated that they droped April off at the road and then they drove up to the business. Him and Banks got out with Banks behind him and they went into the place. He then stated Banks was yell ing at Mrs. Maloney about where the money was. He then stated that he was leaving out and he heard Banks shoot. I asked him if he knew where the gun was that Banks used to kill her and he shook his head yes. He said that the gun was his. Thats the reason he got tied up in this to start with is because of that gun. Banks wanted to use it and it had street value so he didn't want to just let it go, so he went along. It wasn't supposed to happen that way, but he shot her. I asked him if he knew where the gun is now and he told me in the woods behind his fathe r's house. I asked him if he could take me to it and he stated yes. At that point I contacted Gean Johnson to follow me over there because he is an evidence custodian and Brian Sill went with me for security. He took us down a dirt rode that runs thru the woods behind his Dad's hou se and had me stop at a big bush with shingles on the ground by it. He walked into the woods and pointed at the ground. He said it was under some leaves wrapped up in a blue rag. I moved enough leaves and straw to see the rag and then moved out of the way so Gean could photograph and collect the weapon. I then drove Anthony back to headquarters. I put him in an office and asked Hampton Jenkins to get a written statem
