Incident:

On Monday, 05-20-2024, at approximately 2114 hours, I responded to United States Highway 52 and Stephanie Drive, in reference to a motor vehicle collision with injury. I responded with emergency lights and sirens which activated my recording equipment.

NARRATIVE

Investigation:

Upon my arrival, with my recording equipment activated, I made contact with Officer Reynolds. I spoke with Officer Reynolds to gather information he had about the collision. Officer Reynolds advised that bystanders on scene stated that Kathryn Dennis was possibly impaired. At that point, Ms. Dennis walked up to myself and Officer Reynolds and I observed Ms. Dennis had glossy eyes. The fire department was also dispatched to the scene however, due to having both lanes of traffic blocked, they were having difficulty navigating vehicles while attempting to come on scene. As a result, I departed from Officer Reynolds and Ms. Dennis and assisted in clearing traffic so emergency vehicles could arrive. Upon their arrival, I returned to Officer Reynolds, who advised that bystanders could smell the odor of alcohol emanating from Ms. Dennis' person. Officer Reynolds advised that the GMC Canyon was the vehicle Ms. Dennis was driving. I went to the vehicle and noticed an unopened mini bottle of Fireball on the driver's side floorboard. I went to the passenger side and noticed a brown dog bag on the floorboard. I noticed a pink tumbler cup in the center console that was empty.

I located Ms. Dennis who was holding a dog and being checked out by EMS. While standing near Ms. Dennis, I could smell an odor consistent with the odor of alcoholic beverages emanating from her. Once EMS was done with their evaluation, and Ms. Dennis refused to go to the hospital, I engaged her in conversation. I asked Ms. Dennis where she was coming from tonight. She advised that she went out around 1830 hours, to meet friends to record a podcast. Ms. Dennis advised that the

podcast did not work out and she went to "The Standard" apartment complex in James Island to catch up with her friend. I asked Ms. Dennis if she had anything to drink or eat tonight. Ms. Dennis advised that she did not. I asked Ms. Dennis if she took any prescription medicine. Ms. Dennis advised that she took several medications but had not taken any tonight.

I asked Ms. Dennis if she would submit to the Standardized Field Sobriety Tests (SFSTs). Ms. Dennis advised that she would. I went to my marked patrol vehicle and moved it for testing purposes.. I secured Ms. Dennis' dog and brown dog bag in the rear compartment of my patrol vehicle for safety. I escorted Ms. Dennis to the front area of my patrol vehicle. Prior to any testing, I asked Ms. Dennis if she wore glasses or contacts, Ms. Dennis advised she wore contacts. I inquired about any physical impairments that would prevent her from completing the tests to which she stated she did not.

The first field sobriety test was the Horizontal Gaze Nystagmus test (HGN). I demonstrated to Ms. Dennis how I wanted her to stand, and I explained the instructions for the test. While standing in front of Ms. Dennis I could smell an odor consistent with the odor of alcoholic beverages emanating from her person. I asked Ms. Dennis if she understood the instructions and she indicated she did understand. I began the test. I found that Ms. Dennis' pupils were equal in size, and her eyes were tracking equally. During the test, I observed lack of smooth pursuit in both her left and right eyes, and I observed distinct and sustained Nystagmus at maximum deviation in both her left and right eyes. I did not observe onset of Nystagmus prior to forty-five degrees in both her left and right eye. I did not observe vertical Nystagmus. I observed in total four clues out of six while conducting HGN testing.

The next test that was conducted was the walk and turn. I gave Ms. Dennis the option of removing her sandals or keeping them on and after explaining the test, Ms. Dennis decided to remove her sandals. I examined the ground and noticed that the area we were standing on was level. I instructed Ms. Dennis how to stand in the starting position, I demonstrated how to stand, and advised her to stay in that position until I told her to begin the test. During the instruction phase, I observed Ms. Dennis could not maintain balance in the starting position. Ms. Dennis advised that she did not have good balance. After demonstrating the test and providing instructions multiple times, I asked Ms. Dennis if she understood, and she indicated she understood. I then advised Ms. Dennis to begin the test when she was ready. During the walking phase I observed Ms. Dennis use her arms for balance and misses heel to toe on numerous occasions. In total I observed three out of eight clues on the walk and turn.

The next test that was conducted was the one leg stand. I demonstrated to Ms. Dennis the test and provided the test instructions. I asked if Ms. Dennis understood the directions, and she indicated that she did. Ms. Dennis then attempted the test. I did observe Ms. Dennis use her

arms for balance and puts her foot down. In total, I observed two out of four clues on the one leg stand.

Upon completion of the tests, Ms. Dennis asked where her dog was, and I reminded her that she had placed her dog in the back seat of my patrol vehicle. Based on my observations, I determined that probable cause existed for the charge of Driving Under the Influence. I escorted Ms. Dennis to the front of my marked patrol vehicle. I placed Ms. Dennis in handcuffs to the rear, double locked them and checked them for fit. I advised Ms. Dennis of her Miranda Rights in front of my dash camera. Based on what Ms. Dennis was wearing it appeared that she did not have any contraband on her person. I escorted Ms. Dennis to the rear passenger compartment of my marked patrol vehicle which was checked for contraband and met with negative results. I removed Ms. Dennis' dog and brown dog bag from the rear passenger area. I placed Ms. Dennis in the rear of my patrol vehicle and secured her in a seatbelt. I conducted a search of her brown dog bag and located several mini bottles of Fireball, some of which were opened and empty.. I took photographs and attached the photographs to this report and then deleted them from my personal cellular phone.

NARRATIVE

Officer Reynolds and Officer Baldwin stayed with the vehicle and completed the inventory sheet and collision report. I departed the scene enroute to the Goose Creek Police Department. Upon my arrival, Ms. Dennis, who was upset about the arrest, stated that I did not perform field sobriety tests. I secured my department issued firearm in the trunk of my marked patrol vehicle. I removed Ms. Dennis from the rear of my marked patrol vehicle and escorted her into the detention area and completed a contraband check of the back seat after removing Ms. Dennis which met with negative results.

I activated the DataMaster recording device prior to entering the DataMaster Observation Room. I secured Ms. Dennis in cell number two while I obtained her criminal history and booking paperwork. I removed Ms. Dennis from cell number two and escorted her into the DataMaster Observation area of the Detention Center. I advised her she was being recorded by video and audio devices. While speaking with Ms. Dennis, she admitted to drinking alcohol 'way earlier' despite having previously told me she had none. I read Ms. Dennis the Advisement of Implied Consent Rights Form and provided Dennis with her copy to follow along. Ms. Dennis allowed me to check her mouth for any foreign material, which was met with negative results. After the twenty-minute observation period, Ms. Dennis was afforded the opportunity to provide a breath sample and refused. I completed the notice of suspension. I completed the booking paperwork and provided Ms. Dennis with her copies. I tried to get a booking photograph of Ms. Dennis, but she did not want me to. I took photographs with the camera inside the DataMaster room.

After completion of the DataMaster process, I resecured Ms. Dennis in handcuffs, double locked and

checked for fit, and resecured her in a seatbelt in the back seat of my patrol vehicle, after another contraband check. I transported Ms. Dennis to the Moncks Corner Trident Emergency Room for jail clearance. While at the hospital Ms. Dennis admitted to the doctor to consuming alcohol earlier tonight. Ms. Dennis could also not recall when the collision happened, even though she had looked at her timeline earlier at the collision scene. Medical personnel checked Dennis who refused treatment and provided me with discharge paperwork.

I transported Dennis to the Berkeley County Detention Center. Upon my arrival, I secured my weapon in the trunk of my patrol vehicle and removed Dennis from the rear passenger seat of my marked patrol vehicle. A secondary search for contraband resulted in negative results. f. I escorted Ms. Dennis into the booking area. The Goose Creek Police Department handwritten booking report was provided to staff with the Berkeley County Detention Center. All paperwork was reviewed, and custody of the prisoner was signed. Custody of Ms. Dennis was turned over to the Berkeley County Detention Center Staff for lodging pending a bond hearing. I advised Ms. Dennis of her citations, court date, time, location, and bond the amount.

inquired [REDACTED] about what happened to which he stated that he was hit in the rear by Dennis's vehicle while he was stopped in traffic for the red light at the N Goose Creek Boulevard and Stephanie Drive intersection. [REDACTED] advised that he was just getting ready to drive as the light just turned to green. [REDACTED] advised that Griffin's vehicle was directly in front of his when he was collided with.

I then made contact with Officer Armoogam who was standing with Dennis as she was getting checked by the City of Goose Creek Fire Department. Dennis was telling her side of the collision as I made contact to which she advised that she was driving and saw the vehicle in front of her stopped to which she then tried to brake as fast as possible. I inquired Officer Armoogam about anything else Dennis said to which he stated that Dennis was traveling and did not know why the vehicles in front of her were stopped and collided with them.
