NARRATIVE
ON 06/30/2024, R/O RESPONDED TO THE INCIDENT LOCATION IN REFERENCE TO AN ASSAULT THAT HAD JUST OCCURRED.
UPON ARRIVAL, IT WAS LEARNED THAT ALL THE VICTIMS WERE ON THE SIDEWALK IN FRONT OF THE INCIDENT LOCATION PERFORMING A PEACEFUL PROTEST WHEN AN OLDER WM WEARING A TEAL SHIRT (OFFENDER) CAME OUTSIDE OF THE CHURCH SIDE DOOR AND PICKED UP THE PORTABLE PRESSURIZED SPRINKLER OUT OF THE GRASS, INTENTIONALLY SPRAYING VICTIMS 1-5. THE OFFENDER WAS SPOKEN TO BY PFC MCCLUSKEY AND ADMITTED TO HIS ACTIONS DUE TO HIS WIFE'S FRUSTRATIONS.
WARRANTS FOR ASSAULT 3RD DEGREE ARE BEING SOUGHT ON THE OFFENDER.
