

I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

That on or around November 4, 2023, during an altercation that occurred on the property located at [REDACTED] located in the town of Varnville, County of Hampton, State of South Carolina, one Perry Mcalhaney, did commit the offense of A&amp;B 3rd Degree. The victim was hunting on the property from a deer stand located in a tree. The victim received permission and paid approximately \$500 to the property owner to allowed him access to the property. Perry McAlhaney arrived on scene and accused the victim of trespassing. McAlhaney retrieved a chain saw and began cutting the tree that contained the victim down. The victim recorded the incident on his cellphone and provided the footage to SLED. McAlhaney provided a statement to SLED admitting to attempting to cut the tree down while the victim was sitting in the deer stand. In that the defendant attempted to injure another person with the present ability to do so.

AFFIDAVIT

Personally appeared before me, a Magistrate of HAMPTON County, one SENIOR SPECIAL AGENT  
RYAN KELLY who first being duly sworn, deposes and says that

**PERRY ZACHARY MCALHANEY**

Did within this County and State on or about NOVEMBER 4, 2023, violate the criminal laws of the State of South Carolina in the following particulars:

**DESCRIPTION OF OFFENSE**  
**ASSAULT AND BATTERY 3<sup>RD</sup> DEGREE**  
**VIOLATION OF SECTION 16-3-600(E)**

The affiant states there is probable cause to believe that the defendant named above did commit the crime(s) set forth, and that such probable cause is based upon the following facts:

That on or around NOVEMBER 4, 2023, during an altercation that occurred on the property located at [REDACTED], located in the town of Varville, County of Hampton, State of South Carolina, one PERRY MCALHANEY, did commit the offense of **ASSAULT AND BATTERY 3<sup>RD</sup> DEGREE**, in violation of section 16-3-600(E) of the South Carolina Code of Laws of 1976, as amended.

In that on NOVEMBER 4, 2023, the victim, [REDACTED] was hunting on the property located at [REDACTED]. The victim was hunting from a deer stand located in a tree. The victim had previously received permission and paid approximately \$500 to the property owner for a hunting lease, which allowed him access to the property. The property owner confirmed to SLED she gave permission to and received payment from the victim.

In that the defendant, PERRY MCALHANEY, arrived on scene and accused the victim of trespassing. The defendant, who lives on an adjacent property, then retrieved a chain saw and began cutting the tree that contained the victim down. The victim recorded the incident on his cellphone and provided the footage to SLED.

In that the defendant, PERRY MCALHANEY, provided a post Miranda statement to SLED admitting to attempting to cut the tree down while the victim was sitting in the deer stand. The defendant stated he was aware his actions could have caused serious injury or death to the victim if he successfully cut the tree down.

In that the defendant attempted to injure another person with the present ability to do so

The above information is true and accurate and was obtained through witness statements and the investigation of the South Carolina Law Enforcement Division.
