## Primary Narrative By Johnathan Goldsmith, 01/06/20 16:39

I was dispatched to the area of the boat ramp on Highway 1 South at the Wateree River, they advised Sumter County was getting a ping for a stolen vehicle coming from that area. I arrived on scene and noticed the vehicle parked on the West side of the bridge near a light pole, it seemed have been sitting there for a few hours. The vehicle was the only one in the area of the boat ramp. I advised dispatch that, I possible had located the vehicle. I confirmed with dispatch on what type of vehicle I was looking for a white in color GMC Yukon. I exited my vehicle and began clearing the vehicle with my firearm drawn, the side windows on the Yukon were extremely dark, so I went to the front of the vehicle so I could observe anything inside. I could see the suspect sitting in the back seat of the vehicle, he appeared to be sleeping. I got the suspects attention by giving loud verbal commands. The suspect was a white male possible mid to late 30's, the suspect had tattoos on his chest and hands, he also wore large silver in color rings on his hands. The suspect had dark hair as well as a goatee, the suspect was sweating profusely though the temperature outside was close to 40 degrees, and the vehicle was not running. The suspect appeared to be under the influence of narcotics.

I continued giving the suspect loud verbal commands even though he would not comply with my commands, I told him to exit out the front passenger door with his hands up! The suspect then began reaching underneath the back passenger seat in order to retrieve something, I again advised him to show his hands which he complied momentarily. I had dispatch send additional units to my location and that I had the suspect at gun point. The suspect continued not complying with commands, though I had my firearm on him the entire time. Once backup arrived the suspect began locking all the doors so we were not able to open the doors. The suspect again began reaching around inside the vehicle for something though we gave him commands to exit the vehicle with his hands up. The suspect then grabbed a pack a cigarettes and lit one then sat back down, he kept stating he didn't do anything wrong though he would not open the door. The suspect then sat up and went toward the driver's seat grabbing a book bag that had been sitting in the driver's seat, when he threw the bag in the passenger seat I told my back-up officer he was going to take off at that point we ran to our vehicles. As I got to my vehicle, the suspect got his vehicle started and took off at a high rate of speed throwing rocks at our vehicles.

We activated our blue lights and sirens then began chasing the vehicle, I notified dispatch the we were in pursuit of the vehicle. The vehicle had to wait for traffic to clear at the boat ramp exit and US-1 South, which allowed me to catch up to vehicle. Once he accelerated again, I maneuvered my vehicle in front of the suspect vehicle to avoid any citizen vehicles from being struck. The suspect over corrected once I maneuvered in front of his vehicle, driving into the grass median and began losing control of the vehicle. I followed alongside the vehicle attempting to get the vehicle to stop, though the suspect was able to get the vehicle under control, getting the vehicle back onto the pavement heading South on US-1. The suspect passed vehicles on the shoulder and ran traffic lights, we already had units at 2 of the intersections. After the suspect passed through the US-1/Highway 34 intersection the suspect merged onto Hwy 601 toward Richland county. The suspect vehicle committed multiple traffic infractions driving into oncoming traffic multiple times, forcing vehicles off the roadway in an attempt to flee. The suspected slowed drastically on 601/Lees-burg Rd as if he was attempting to turn onto Lees-burg Rd, but accelerated once again. We continued pursuing the suspect down 601 waiting for units from RC-SO and SC HP to assist, the suspect turned onto HWY 378 East bound in the West Bound lanes of travel. County units followed the vehicle in the Eastbound lane of travel, the suspect then went onto the shoulder of the roadway and kept heading East, shortly before the pursuit was terminated. The vehicle was last seen heading East on HWY 378 in the westbound lanes. Sumter County was notified that the vehicle was headed to their jurisdiction. I then returned to KC SO jurisdiction. The vehicle is a White in color 2007 GMC Yukon with dark tinted windows and all black wheels VIN 1GKFC13087J147601. The vehicle had a temporary license plate. No other information could be provided at this time.

## Primary Narrative By Johnathan Goldsmith, 02/29/20 03:05

I observed the suspect vehicle driving on US-1 near Halie St heading South with its bright headlights on while passing another motorist to include myself. I turned around on the vehicle finally catching up to it on US-1 before DELOACH St, I activated my blue lights for the vehicle to stop. The vehicle turned onto DELOACH St, at a low speed but did not stop, the driver continued heading down DELOACH St. at a speed of about 15 miles per hour. The suspect turned on his 4 ways though he did not stop, the vehicle crossed the double yellow line twice. I then activated my siren to get the vehicle to stop though he continued driving at about 15 miles per hour, the vehicle finally pulled into a residence at 1004 Sherwood LN.

I made contact with the driver (SP) the suspect seemed extremely nervous and flustered when I spoke with him, he had trouble locating his license as well as his registration. The suspect stated he had been drinking and that he recently left a friend's house. He said that the switch for the headlights was having trouble and that he could not see to well and had to drive with the bright headlights on. I could smell the odor of alcoholic beverage coming off his breath and person. I went back to my vehicle to run the suspects driver's license through dispatch, they advised me that the suspect had a current suspension to his SC DL for insurance. I went back to speak to the suspect, who still had trouble locating his registration and insurance. I asked him to step out of the vehicle, though he was still attempting to locate his insurance paperwork, the suspect was stalling talking on the phone instead of exiting the vehicle.

I had him move to the rear of the vehicle, and I shut the driver's door. I began talking to suspect when he told me he had recently drank 2 shots of alcohol along with at least 3 beers about an hour prior to being stopped. I then asked if he would consent to a field sobriety test, the suspect began stating he was already home so he didn't believe he needed to take the exam. I explained to him that he admitted he had been drinking and I observed him driving. He again began stalling not answering my questions, he eventually refused to take fst's. I then told him to place his hands behind his back, he began to put his hands behind him, before stating he would conduct fst's. I told him its was too late, he initially placed his hands behind his back, then suspect began to pull away from me in the direction of the driver-side door. I was attempting to hand cuff him door before, the suspect broke away from me, headed back toward the driver's door. I pushed the suspect against the vehicle trying to restrain him the suspect shoved me with both arms to get me away from him, I delivered a stunning strike to the left side of the suspects head though it was ineffective. The suspect was stilling actively resisting pushing and refusing to comply, I administered 2 knee strikes to the suspect while telling him to stop resisting. When the suspect leaned over, I was able to secure him around the waist and take him to the ground.

Once I got the suspect was on the ground, I was still giving him verbal commands to stop resisting. The suspect was attempting to get up when I delivered a stunning strike to the right side of his head. The suspect was still combative and refusing to be hand cuffed, I delivered 2 straight punches to the suspects abdomen when he stopped resisting and allowed me to handcuff him. I removed the suspect from the ground at that point escorting him back to my vehicle, he was placed in the rear of my vehicle, when he stated he need ems. I began searching the suspect vehicle when, I could clearly see a tan in color handgun hanging from underneath the driver's seat, laying on the floor. I removed the firearm and cleared it, I then ran the serial number 17AT12985 a (Canik Tp9 9mm) with an 18 round magazine with 16 rounds in it, the weapon came back clear. I asked dispatch to check if the suspect has a concealed weapon permit? I asked the suspect if he had a permit which he stated he did not. Once backup units arrived on scene, I continued clearing the vehicle, locating 4 total bud light cans the suspect had tossed on the back right floor board of his vehicle. One of the cans was cold to touch and still had about half of the liquid inside it. I collected all the evidence form the scene transporting it back to KC-SO, turning it over to the evidence custodian box 18.

Ems arrived on scene to evaluate the suspect who was still non-compliant, the suspect was very agitated yelling and arguing with myself and EMS. He stated he wanted to go the hospital. I decided to transport the suspect to avoid him causing an issue with EMS. The vehicle was towed from the scene by Sanders. I transported the suspect to the KERSHAW ER, where he was eventually cleared for jail by medical staff. Once at the detention center, I read the suspect his implied consent before waiting the standard 20-minute observation period. Once the machine was ready to receive a sample, the suspect did submit a breath sample a .06 B.A.C. I gave the suspect his copy before escorting him to the booking area. Nothing else follows.

I observed the suspect vehicle heading South on US-1 just past the entrance to Walmart, the vehicle crossed the fog line multiple times before quickly turning into the Food lion parking lot. I pulled up to the suspect vehicle a dark in colored Nissan Altima Plate number(PAP836) and spoke to the driver believing the driver may have been a employee headed to work. The suspect operating the vehicle (AB) stated they where lost and were attempting to head in the direction of Sumter. I exited my vehicle and spoke to the driver (AB) who initially gave me a false name but could not remember her correct birth date, she eventually gave me her real name and stated she was suspended. The front passenger who was identified as (FS) stated the vehicle belonged to her and gave me the registration for the vehicle.

The back right seat passenger who was identified as (JH) was laying in the back appearing to be asleep. I went back to my vehicle when dispatch advised me the license plate from the vehicle was suspended and belonged to a Chevy SUV from Shaw air-force base. I had the driver step-out once backup arrived on scene, when she exited the vehicle she dropped a small plastic baggy oh a green leafy substance on the seat behind her. I secured the substance and asked was there anything else inside the vehicle besides the marijuana I found, she admitted the marijuana was hers.

We then had all the other suspects exit the vehicle and they where all searched for weapons and narcotics, we began searching the vehicle though we did not locate any additional narcotics inside the vehicle. The two females where detained in the back of my vehicle, while the male talked to backup deputies outside the vehicle. One of the backup officers noticed a bugle hanging out of the front of the male suspects pants, it was a clear plastic baggy with a white Crystal like substance inside believed to be Methamphetamines. When deputies attempted place the suspect under



arrest the suspect fled on foot toward the wood-line, before he was eventually tackled by deputies and taken into custody. I went back to insure the females in my vehicle did not have any other narcotics on their person, I had both females take their shoes off and empty their pockets again. After speaking with the driver (AB) I advised her she was under arrest for DUS 1st. She was then transported by another deputy to the detention center and the male suspect who was complaining of pain was transported to the hospital. A search was conducted of (AB) at the detention center locating a baggy of a white crystal like substance, which had been concealed inside a body cavity. The evidence was secured and taken back to KC-SO and turned over to evidence custodian placed in evidence box 19.

The other suspect who was inside the vehicle (FS) was released with out charge and was allowed to call a ride, the vehicle was towed form the scene by Patterson's.

## **Supporting Narrative By Erin Miles, 02/29/20 22:56**

On 02-29-2020 at 0517hrs I Deputy E Miles responded to 610 Highway One South in Lugoff, area of Kershaw, South Carolina in reference to Deputy Goldsmith needing assistance. Upon my arrival, Deputy Goldsmith observed a clear baggy containing a green leafy substance near the driver's area of the vehicle Deputy Goldsmith was out with. Based on that probable cause, I asked the occupants of the vehicle to step out. As one of the occupants was standing to the rear of the vehicle after I conducted the probable cause search of the vehicle, I observed the occupant to have a clear baggy with a clear substance sticking out of his waist band. I retrieved the item, believing it to be methamphetamine, and handed it to Deputy Goldsmith. I then advised the male occupant that he was not being detain. Myself and SGT Hudson reached to put hand cuffs on him at which time the male occupant started running toward the wood line of the grocery store. I caught up to him, but fell when I reached to grab him. I then got back up and caught up to him again as did Deputy Goldsmith. Deputy Goldsmith grabbed the man's pants, but the male continued to try and run. At that point and time I conducted a take down while I was running after him in an attempt to place him under arrest. Myself and the male suspect went down a 20 foot drop off and landed on a tree. After we landed, I gave loud verbal commands for the man to place his hands behind his back. The man would not comply, but it was obvious he was hurt from the fall. I then placed the hand cuffs on him facing his front torso and assisted him to his feet. I then escorted him to SGT Hudson's patrol vehicle. After the scene was deemed safe, I noticed my body camera was ripped off my duty vest from the altercation. SGT Hudson located the body camera in the wooded area near the 20 foot drop off. The body camera was damaged and is not wearable, but still recorded the event.

**Primary Narrative By Johnathan Goldsmith, 03/14/20 15:46**

I arrived on scene to find both suspects (MC) and (DH) we're sitting outside, with their children and one of the suspects god mother. The god mother left before I began talking with the suspects. The suspect (MC) appeared to be highly intoxicated, she almost instantly became belligerent asking me if I think I scare her. The suspects 15-year-old son was sitting next to her who stated her and the other suspect (DH) had been arguing constantly. She kept stating that I did not scare her, she admitted that she already had been drinking. She then stated I wasn't taking her kids or I would have problems! The suspect (MC) then began yelling at (DH) to put the kid down because she was not playing with him anymore, trying to start a fight. When I asked the suspect her name she said her name was (Teresa Hudson), her son who was sitting next to her said her name was not Teresa but her name was Molly. When I asked her what her last name was she again stated her name was Teresa Hudson, her son gave me her full name (MC). "He then told her that you know you're going to go to jail for that!" She continued being uncooperative, saying if I thought I was going to come in her yard and take her to jail that's not going to work! When I have asked her why did she give me a false name "she said that she didn't trust the police, she then stated she didn't give a fuck". I then decided to detain the suspect, I asked her to get off the stairs she began to pull away from me, I pulled her off the stairs and she began passively resisting not letting me handcuff her. Her son who was sitting next to her asked her to comply, though she did not, I had to utilizing a wrist lock to get her to comply. I got the second suspect's name (DH) and ran both the names through dispatch. Dispatch then notified me that the suspect (DH) was wanted out of Florence, I detained the suspect (DH) while I waited for the warrant to be confirmed.

The suspect (MC) began to walk away upstairs away from me even though I told her to sit down. I escorted both suspect to my vehicle, when she began "stating I fucking hate you directed toward me." I then advised the suspect she was under arrest for breach of peace. The suspect then began to pull away back toward the home, even though I advised her to sit in my vehicle because she was under arrest. I had to physically pull here, then utilize a wrist lock on her for the second time because she attempted to push past me. Once the suspects (DH) warrant was confirmed, I advised him he was under arrest, I placed the suspect in my vehicle. I had to wait for a guardian to arrive on scene to look after the two children, the suspect (MC) continued being belligerent cursing out myself and (DH). Once the guardian arrived on scene I transported both suspects to KC-DC. En-root to the detention center the suspect (MC) did not calm down stating she would fight everyone once you got in jail.

Upon arrival to the detention center, I removed the suspect (DH) because he was being compliant. Once he was inside the booking center, I went back to my vehicle, the suspect (MC) was yelling and cursing at me through the back windows, I advised her she needed to calm down in order to be booked in. The suspect got out of the vehicle and stormed in their direction of the door to the booking area, I was not able to escort her to the door in the manner she was walking. I closed the door on my patrol car and locked the door before heading in the direction of the suspect. The suspect was standing near the door at that point, as I got closer to her she turned around and began to charge at me as if she wanted to spit or kick me. I stopped the suspects momentum by pushing her shoulders, due to the suspect level of intoxication she fell down on her behind. The suspect (DH) who was now un-cuffed in the booking area ran to door and began violently kicking and punching the glass on the door in an attempt to come assault me. I grabbed (MC) by the back of her neck then applied the mandibular angle with the thumb on my right hand, the pressure point was



ineffective at that point, so I utilized my left hand which was on her chin to stabilize her head and used both my left and right thumbs to apply pressure. The pressure point was finally effecting utilizing both hands and the suspect stopped resisting. The detention center staff was able to get the suspect (DH) under control and remove him. I kept my hands on her left shoulder and on the back of her neck in case the suspect began resisting again. I walked her inside the booking where she continued being uncooperative with jail staff and had to be escorted directly to a single cell. The suspect (DH) has no county charges, and the suspect (MC) is being charged with resisting arrest, false information to police, breach of peace.

## Primary Narrative By Brad Lawson, 04/19/20 18:22

Around the middle of March 2020, this officer received a tip in regards to a subject in the Cassatt area of Kershaw County selling marijuana as well as other illegal drugs. The tip was that the subject was selling in the Cassatt area of the county, to include in and around the Sheppard Acres Trailer Park area. The tip also was that the male subject was to possibly be driving around in a white in color Honda Accord. From this tip, this officer also received a few pictures that were taken from the subjects Facebook account and what looked to be Instagram account. From these pictures this officer was able to identify the subject as Thomas Richard Johnson Jr. The pictures from the tip showed Mr. Johnson posting numerous pictures of marijuana in bags as well as numerous pictures of himself. On the Facebook account it list Mr. Johnson's name as "Thomas Real Johnson". The Instagram account shows him having larger bags of marijuana and a large jar full of marijuana. This officer as well as other narcotics agents are very familiar with Mr. Johnson from previous drug investigations regarding him being charged with distribution of heroin. Agents are also familiar with Mr. Johnson from other drug related cases where he failed to stop for blue lights on two different occasions, and both of those incidents resulted in the recovery of illegal drugs. Since receiving this tip agents have periodically tried to locate and identify the white Honda Accord that Mr. Johnson may be driving and a more specific location of where he could be staying and selling the illegal drugs.

On the date of this incident, April 7, 2020, this officer was riding around the Bishopville Hwy area near the Lee County line, in the Camden area of Kershaw County. While on Bishopville Hwy this officer passed by Favor Rd and several dirt driveways just past Favor Rd. In this general area of these driveways and Favor Rd, agents have received information in the past years of a few large scale drug traffickers from the Camden area to hang out in this area. When passing by Favor Rd and these dirt driveways, this officer observed an older model white in color GMC Yukon SUV about to pull out onto Bishopville Hwy. This officer is unsure if the GMC Yukon was on Favor Rd at the time or on one of the dirt driveways just beyond Favor Rd. This officer was able to clearly see that Thomas Richard Johnson Jr was the driver and sole occupant of the GMC Yukon. Due to the previous drug investigations involving Mr. Johnson and the recent drug tip involving him, I wanted to identify the license plate on this vehicle and see where he may be traveling. Just after passing Stokes Rd on Bishopville Hwy I pulled over and observed Mr. Johnson to make a left turn onto Stokes Rd. I then turned around and began traveling on Stokes Rd behind Mr. Johnson in the GMC Yukon.

The posted speed limit on this section of Stokes Rd is only 45 MPH and this officer could tell that Mr. Johnson was traveling well over the speed limit. Before completely catching up this officer observed Mr. Johnson continuously failing to maintain a proper lane as he crossed over the center line on numerous occasions. Once catching up to him I was able to pace him as he was speeding at about 60 MPH in the 45 MPH zone. Before approaching Antioch Rd, Mr. Johnson slowed down his speed and I ended up right behind him. He was seen looking at me through the side-view mirror and I could clearly see the tattoo under his eye that I already knew he had. As he was looking at me through the mirror, Mr. Johnson was again observed to cross over the center line. The vehicle was bearing SC tag# 9810NQ. At this point I was going to conduct a traffic stop and emergency blue lights were turned on just before we approached



Antioch Rd. At Antioch Rd Mr. Johnson slowed and came pretty much to a stop. He then accelerated at a high rate of speed after crossing over Antioch Rd and it was relayed to central dispatch that I had a vehicle not stopping. At this point emergency sirens were also turned on.

Just after passing the first house on the right on Stokes Rd, after Antioch Rd, Mr. Johnson was driving in the middle of the roadway and was observed to throw a to-go plate of food from the driver window. Instead of just tossing the plate of food, it looked as if he attempted to throw it in the roadway with force. This officer relayed this information on the radio so that other officers responding could go to the location where this was thrown from the vehicle. Mr. Johnson continued failing to stop at a high rate of speed on Stokes Rd. A ways up from this location, he again threw two more bags from the vehicle as we approached a small bridge crossing over a creek on Stokes Rd. This officer was right on his bumper at this time and one of the bags thrown at this location was observed landing just on the top of the bank at this bridge, leading to the creek. This officer was able to see very clearly that this was a large zip-lock bag and could also see that it contained a white substance within the bag as well as what looked to be amber colored pill bottles. This officer immediately relayed this on the radio and directed other officers exactly where the zip-lock bag was located. Other officers were informed that it was next to a bridge just down from the address of 596 Stokes Rd. This address was relayed on the radio as I was passing by and could read the numerics on the mailbox by the road. Just before the intersection to Lucknow Rd, Mr. Johnson again threw something from the vehicle. This time he slammed a clear jar to the ground and this officer was clearly able to see that it contained marijuana. This officer was also able to smell the odor of marijuana as I came through that particular spot. This was also relayed on the radio to other officers responding. Mr. Johnson was never seen throwing anything else from the vehicle but still continued to flee at a very high rate of speed. As he went through the intersection to Lucknow Rd on Stokes Rd, he went through that intersection very fast, with no regard for any other citizens on the roadway. At the end of Stokes Rd he made a right turn onto Timber Creek Rd. On Timber Creek Rd Mr. Johnson passed another vehicle with another vehicle coming head on in his direction. He then blew through the stop sign at Old Stagecoach Rd to continue on the dirt portion of Timber Creek Rd. On this dirt road he attempted to throw up a lot of dust, in what seemed to be an attempt to make me fall back, making it impossible for me to continue chasing him. We continued on Timber Creek Rd until the end where he made a left turn onto Winchester Dr and then a quick right onto Mt. Zion Rd. Once on Mt. Zion Rd he seemed to slow his speed a little and this officer could see that he was now talking on his cell phone. With the location we were at, I suspected him to be trying to get to his mothers house, which is the location on his driver's license as well. This is 1311 James West Ln, Cassatt, SC. At James West Ln he made a right turn and pulled in the front yard of the neighboring house just past his mothers house.

Mr. Johnson came to a stop in the yard and threw his hands up while still in the vehicle. This officer drew his duty weapon, pointed it at Mr. Johnson while approaching the vehicle. Mr. Johnson then began to chug a bottle of brown liquor, which was thought to be or looked like a bottle of Hennessy. The driver door was opened and Mr. Johnson was taken to the ground where he did not put up a fight or any kind of struggle. My duty weapon was then holstered and he was placed in handcuffs at this time and central dispatch was advised that he was in custody. Mr. Johnson made a voluntary statement claiming that it was his birthday. He was then quickly asked why he did what he did then and he stated what was I supposed to do, just stop knowing it was you and me having marijuana and alcohol in the vehicle. Just a short time later, Inv. Bass and Deputy Goldsmith arrived on scene. A search of the vehicle was conducted with nothing further being located in the vehicle except another open bottle of Hipnotiq alcohol.

Mr. Johnson was transported to the KCDC by Deputy Goldsmith without any further incident. Inv. Bass waited for Skee Balls Towing, who was contacted off of rotation, to tow the 1995 GMC Yukon belonging to Mr. Johnson.

Within just a few minutes of calling out where the items were thrown from the vehicle and capturing Mr. Johnson, I was notified that Trooper J. Oxandabourn had located the zip-lock bag next to the creek. This was the zip-lock bag that I observed a white substance within the bag and the amber colored pill bottles. I was informed that it contained cocaine or either crack-cocaine. As I was tracking back to the locations Sgt. Hudson, Deputy Powers and Deputy Martin were standing in the road on Stokes Rd, just before Lucknow Rd. This was the location where Mr. Johnson threw the glass jar of marijuana from the vehicle. All four of us participated in picking up as much marijuana as we could from the middle of the roadway and both shoulders of the roadway. On the shoulder laid the broken jar that was clear in color with a red and green markings on it and it also had a metal clasp to close the jar. This officer remembered the photos provided from the tip in March and looked back at those photos. In those photos was this exact same jar, filled with marijuana. In all we collected approximately 63 grams of marijuana. I then made my way to Trooper Oxandabourn at the small bridge down from 596 Stokes Rd. He was there with Inv. Spivey, Inv. Carter and Inv. Ross. He turned over the large zip-lock bag that contained four amber colored pill bottles as well as several baggies containing a white and off-white substance. Also in the zip-lock bag was a black in color digital scale. He showed me exactly where the bag was located and it was just at the bottom of the bank before the creek. Note, nothing else was remotely located in this spot except an old beer can that had been there for a while. This officer did take photos of this exact location where the bag was located. I informed the other officers that I thought two bags were thrown from the vehicle at the location



and I was advised there was another black plastic bag with what looked to be hotdog wrappings in the bag. This was located just on the other side of the bridge. In a later interview with Mr. Johnson it was told that he did throw a bag of trash with hotdog wrappings out the vehicle. When examining the contents of the zip-lock bag we located two baggies of cocaine, two baggies of crack-cocaine, one baggie of methamphetamine, two baggies of heroin, one baggie with MDMA/Ecstasy tablets, a bag of a cutting agent, four pill bottles and the digital scale. Trooper Oxandabourn, Inv. Ross and myself then went to the location where the to-go food plate was thrown from the vehicle. I did take a few pictures of food in the road, shoulder of the roadway and the to-go food plate. At this exact location Trooper Oxandabourn advised me that he located a handgun just off the edge of the roadway in the grass. The handgun was noted to have very fresh scrapes on the rear of the gun that obviously had come from being thrown and skidding on the road. This was a Diamond Back DB380 .380 caliber pistol, SN# ZK4625, with a magazine and 7 rounds. This was all the areas where I clearly observed Mr. Johnson throw items from the vehicle.

All evidence collected and seized was transported to the KCSO and secured in a Narc Locker until the following day. On April 8, 2020, all evidence was removed from the Narc Locker. All the drugs were weighed, field tested and photographed along with the other evidence. The marijuana was approximately 63 grams and was placed in evidence. The cocaine, crack-cocaine, and heroin were in two separate baggies. The methamphetamine and MDMA/Ecstasy tablets were in one baggie each. The MDMA/Ecstasy tablets were two different colors, purple and blue, with 17 purple and 10 blue. All of the cocaine, crack-cocaine, methamphetamine, heroin and MDMA/Ecstasy tablets were placed in a SLED Best Kit and placed in evidence for further testing. The Diamond Back .380 pistol was placed in evidence as well. Also placed in evidence was a bag of cutting agent, four (4) amber pill bottles, digital scale and the zip-lock bag.

On April 8, 2020, arrest warrants were obtained and served on Mr. Johnson for: Trafficking Heroin 14-28 grams, PWID Cocaine, PWID Crack-Cocaine, PWID Methamphetamine, PWID MDMA/Ecstasy, PWID Marijuana, Unlawful Carrying of a Pistol, Possession of a Weapon During the Commission of a Violent Crime, and Failure To Stop For Blue Lights and Siren. He was also issued citations for Littering and Broken Seal of Alcohol in vehicle.

On April 9, 2020, this officer had Mr. Johnson transported to the KCSO so that he could be interviewed. Mr. Johnson was read his Miranda Rights, stated he understood his rights and also signed a Miranda Waiver, wishing to continue to speak with me. At first, I wanted to speak with Mr. Johnson about the incident occurring on April 7, 2020, in which he was arrested for. We began with where I saw him and where he was coming from. He admitted that he was hanging with some guys down the road where I initially saw him and that he was there drinking with them. We also spoke about the reason I got behind him and why he was being stopped. I advised him that he was all over the roadway and crossing the center line and he stated that he was eating food while driving down the road. He did not want to get into the facts of what all was thrown from the vehicle, basically stating he was not going to help make my case any better against him. As we spoke about the charges against him, he made a comment that I could have just charged him with DUI. This was taken as an admission and confirmation of him drinking alcohol prior to being stopped and may have also led to his failing to maintain a proper lane. At one point in the interview we began talking about his bond and if he was going to be able to bond out. He stated that he ain't broke and that you see what I had. With the amount of drugs recovered and the street value of those drugs, this was clearly taken as him speaking about the heroin, cocaine, crack-cocaine, methamphetamine and marijuana that he threw from the vehicle. He did however admit to throwing a plate of food from the vehicle as well as the jar of marijuana, a bag containing food wrappings from hotdogs and some type of container with alcohol. He would never admit to throwing a gun or the zip-lock bag that contained the heroin, cocaine, crack-cocaine, methamphetamine and ecstasy tablets. Due to him not wanting to fully cooperate at this time and be truthful about himself or give information, the interview was ended. He was then transported back to the KDCD.

Sgt. Young and myself then looked up Mr. Johnson's Facebook account and observed a picture he posted earlier in the day before this incident occurred. The picture showed Mr. Johnson standing on the hood of the GMC Yukon holding the same liquor bottle he was drinking from when apprehended. He was also observed in the photo to have a pocket full of a bundle of currency. On the hood of the vehicle between his feet is the same jar located on the side of the road where he threw the marijuana from the vehicle. There is also an assault rifle laying on the front windshield.

On April 17, 2020, Sgt. Young and I listened to all phone calls Mr. Johnson made from the KCDC during the time he was in jail before making bond. He made about nine calls that were about five minutes each. When speaking with an unknown female he made a comment that he got himself into this mess. He never spoke much about his charges or any details to the case. He did on a few occasions speak about having enough money to make bond. He stated that he had six(6) bands to give to a bondsman. In my training and experience working narcotics, this is a slang term used by drug traffickers meaning that he had \$6,000. This seemed to be a lot of money for someone to just have readily available to make bond. From my knowledge Mr. Johnson does not even currently have a job to reasonably be able to have that much money readily available.

**Primary Narrative By Johnathan Goldsmith, 04/21/20 22:22**

Units were dispatched to 2691 Old Georgetown RD W for a suicidal person the complainant said (MT) stated multiple times he was suicidal. The complainant said, that they hide the firearms from him though, he stated he would cut his throat with a knife. The complainant said the suspect (MT) had left the complainants home at that time, and went to his residence which was next door at 2675 Old Georgetown RD. En-route to the incident location the complainant informed dispatch that the suspect (MT) stated that he would fight the police when they arrived. I arrived in the area and asked dispatch where was the suspect currently, they made contact with the complainant (WB) the suspects cousin. The complainant said the suspect was not at his residence 2691 and was still at his own address 2675 Old Georgetown Rd. Additional units were already on the way to the scene, I informed dispatch to have the complainant come to the roadway to speak with me since the suspect was not there.

I pulled into the driveway of the complainant's residence 2691 Old Georgetown, I began speaking with the complainant (WB). He said his cousin (MT) had stated to multiple family members he wants to commit suicide, he stated the suspect was possible under the influence of narcotics. While speaking with the complainant, he pointed out the suspect who was standing near the front door of the complainant's residence. (WB) stated the suspect had returned prior to me pulling onto the scene. (WB) stated that suspect was more than likely going to fight law enforcement, he had stated that multiple times to the complainant. The suspect seemed to be speaking with family members, he was walking around agitated and cursing. The suspect then began to walk away, before turning around and coming back. He again began talking to other subjects on scene, before he again walked away headed in the direction of his home.

I did not want the suspect to get back to his home where he could arm himself, so I made contact with him. He stated he did not want to talk to me, and he was extremely agitated and sweaty as if he was under the influence of narcotics. As I approached the suspect and identified myself as law enforcement, the suspect took a bladed stance and quickly reached for his back pocket. I drew my firearm and ordered the suspect to show his hands. The suspect removed his hands from behind him then reached into his front pockets, I again told the suspect to show me his hands. After the suspect complied with showing me his hands, I ordered him to lay down on the ground which he ignored. I holstered my firearm, once I could see the suspect had nothing in his hands. I approached the suspect within 6 feet, so I could explain to him, I was there to insure he did not hurt himself. The suspect stood directly in front of me in an aggressive posture, I asked the suspect was he feeling as if he wanted to hurt himself. He quickly stated "no but I might want to hurt you, you never will know!" I drew my Electronic Control Measure and ordered the suspect to put his hands up. The suspect put his arms, out to his sides but still in close to his own body where he could still fight if need be. I told the suspect again to put his hands up, he still did not comply and I discharged my ECM into the suspect upper abdomen.

The suspect fell down on his side, I had him roll over, on his stomach and I placed the suspect in detention with his hands behind his back. I began searching the suspect emptying out his pocket, when I located a cigarette carton with a red in color cut straw inside it, which is commonly used to inhale illicit narcotics. Units were dispatched to 2691 Old Georgetown RD W for a suicidal person the complainant said (MT) stated multiple times he was suicidal. The complainant said, that they hide the firearms from him though, he stated he would cut his throat with a knife. The complainant said the suspect (MT) had left the complainants home at that time, and went to his residence which was next door at 2675 Old Georgetown RD. En-route to the incident location the complainant informed dispatch that the suspect (MT) stated that he would fight the police when they arrived. I arrived in the area and asked dispatch where was the suspect currently, they made contact with the complainant (WB) the suspects cousin. The complainant said the suspect was not at his residence 2691 and was still at his own address 2675 Old Georgetown Rd. Additional units were already on the way to the scene, I informed dispatch to have the complainant come to the roadway to speak with me since the suspect was not there.

I pulled into the driveway of the complainant's residence 2691 Old Georgetown, I began speaking with the complainant (WB). He said his cousin (MT) had stated to multiple family members he wants to commit suicide, he stated the suspect was possible under the influence of narcotics. While speaking with the complainant, he pointed out the suspect who was standing near the front door of the complainant's residence. (WB) stated the suspect had returned prior to me pulling onto the scene. (WB) stated that suspect was more than likely going to fight law enforcement, he had stated that multiple times to the complainant. The suspect seemed to speaking with family members, he was walking around agitated and cursing. The suspect then began to walk away, before turning around and coming back. He again began talking to other subjects on scene, before he again walked away headed in the direction of his home.

I did not want the suspect to get back to his home where he could arm himself, so I made contact with him. He stated he did not want to talk to me, and he was extremely agitated and sweaty as if he was under the influence of narcotics. As I approached the suspect and identified myself as law enforcement, the suspect took a bladed stance and quickly reached for his back pocket. I drew my firearm and ordered the suspect to show his hands. The suspect removed his hands from behind him then reached into his front pockets, I again told the suspect to show me his hands. After the suspect complied with showing me his hands, I ordered him to lay down on the ground which he ignored. I holstered my firearm, once I could see the suspect had nothing in his hands. I approached the suspect within 6 feet, so I could explain to him, I was there to insure he did not hurt himself. The suspect stood directly in front of me in an aggressive posture, I asked the suspect was he feeling as if he wanted to hurt himself. He quickly stated "no but I might want to hurt you, you never will know!" I drew my Electronic Control Measure and order the suspect to put his hands up. The suspect put his arms, out to his sides but still in close to his own body where he could still fight if need be. I told the suspect again to put his hands up, he still did not comply and I discharged my ECM into the suspect upper abdomen.

The suspect fell down on his side, I had him roll over, on his stomach and I placed the suspect in detention with is hands behind his back. I began searching the suspect emptying out his pocket, when I located a cigarette carton with a red in color cut straw inside it, which is commonly used to inhale illicit narcotics. I also located a napkin on the suspect which had a white crystal like substance located inside of it. Backup units removed the probes from the suspect and I placed him in my vehicle. We then began speaking to all the family members present including the suspect mother. After speaking with all the individuals on scene and the suspect we concluded not charge the suspect, and to assist him in seeking help for his suicidal tendencies. We informed the suspect he would be transported to KERSHAW Health. I transported the suspect to KERSHAW ER without incident and put the suspect on a mental hold.

### Primary Narrative By Johnathan Goldsmith, 05/24/20 05:04

Units were called to the scene of 130 Hollow Tre Ct for the complainant claimed to have picked up the suspect at the boat landing on Lake Wateree. I arrived on scene and spoke with the complainant (DA) and his son (JA), (DA) claimed he met the suspect (KJ) on social media. The suspect refused to leave the suspects home at that point stating she was going to sleep on the couch. The complainant told her she could not sleep inside because his son was home, and did not want the suspect inside his home due to her level of intoxication.

We went inside to speak with the suspect (KJ) when the complainant advised her she could sleep in a hotel and he would pay for it so that she did not have to sleep in her car. The suspect was extremely intoxicated slurring her words and smelled of alcoholic beverage on her breath and person. I asked the suspect could she call a ride or accept the hotel room the complainant was offering her. The suspect said she had a ride coming from Lancaster County, I told her the complainant would allow her to wait inside in her car. The suspect then stated, I needed to call her attorney. I asked her could she collect her belongings and leave the home till her friend arrived. (KJ) was so intoxicated that she did not recognize her phone laying on the floor behind her, she said it wasn't her phone after picking it up. Then she realized it was in fact her phone.

I had the suspect head to the rear door, to get her shoes. She then stated for me not to touch her though I had not at that point. Once at the door the, the suspect got a phone call who she stated was her attorney. She began to back further into the home by way of the kitchen, not leaving the premises as directed. I attempted numerous times to get the suspect's attention verbally, to get to leave the residence. (KJ) continued talking on the phone completely ignoring what, I was trying to direct her to do. I then attempted to steer the suspect toward the rear door because of her level of intoxication. As I moved to the suspect she began to back up in such a manner, I was unable to get around her and she avoided all attempts to be directed to the door. The suspect backed up to the kitchen cabinet, then pushed me away from her with her left hand. I grabbed her right hand again attempting to get her outside the home, the suspect then began resisting attempting to pull her arm away. I applied the straight arm lock to her right arm (pain compliance) so the suspect would stop resisting and I could handcuff her standing. (KJ) was able to bend her arm and turn her body so she was able to use her left hand to break my grip on her arm. (KJ) stated fuck no!! I continued trying to get the suspect to comply turning her back to the counter so I could handcuff her. The suspect would not comply and I utilized a straight arm take down, to prone the suspect out on her stomach to be taken into custody. I escorted the suspect to



the floor by her arm, due to her level of intoxication the suspect fell down hard onto her stomach striking her face on the floor. The suspect was momentarily knocked unconscious from her face striking the floor. I asked the suspect was she ok, while I handcuffed her. I rolled her on her side so her air way was clear when, I noticed she had what I believed to be blood on her nose.

I radioed to dispatch to send EMS to my location for the suspect, I then applied a sternum rub to her to get her to respond. The suspect sat up then began stating to "get out of my fucking house right now". I informed her that we would need to walk outside so she could be treated by Ems, she then refused to get up though I assisted her to her feet. The suspect sat back down on the floor. I was finally able to get the suspect on her feet and escort her to the door, once at the door the suspect refused to go down the steps. I had to force her to walk down the steps into the garage. Once outside backup units arrived, I told them we would take her away from the house to the end of the driveway to wait for ems. Once again the suspect refused to walk and had to be physically pushed to the end of the driveway. The suspect was completely uncooperative and seemed to be heavily under the influence of alcohol and narcotics. We attempted to sit the suspect down so she would not fall down and further injure herself, she refused to follow commands. I attempted the jugular notch to make the suspect sit down which was completely ineffective. The suspect had to be pushed by myself and my backup to sit down for her own well-being. I realized at that point in the light the suspect had some teeth knocked out when her face made contact with the floor. I then began searching the suspects purse locating a pill bottle without a label, the bottle was filled halfway with small blue in color pills. We identified the pills utilizing pill finder.com, we found out the pills were a schedule 4 controlled substance (Alprazolam) 1 MG. The pill bottle was located inside the suspect red in color purse that had been draped across her neck, which also contained another pill bottle which did have her name on it.

I went over to speak with the complainant and his son, the complainant said he met the (JK) on social media a few weeks ago Tinder. The suspect drove from North Carolina and was supposed to spend the evening with him at a few others on the lake. The complaint said the suspect got lost and ended up in Ridgeway Fairfield County. He said he went to meet her there and she was intoxicated at that point, he had her follow him to his residence when they began their evening. After a few hours on the boat the suspect wanted to return to her home in NC. They went back to the incident location when he informed her she was to intoxicated to drive, and that she should sleep in her car. She then went inside his residence then refused to leave when asked. He said the suspect then called 911 stating she had been sexually assaulted, he said he spoke to dispatch and wanted a deputy to remove her from his home.

The suspect was then transported to KERSHAW County ER. For her injuries. Once at the hospital I took photos of the suspects injuries. Inside the ER the suspect continued being aggressive and uncooperative the suspect kicked EMT (WF) in the stomach as he was attempting to assist he into the bed. She then attempted to kick ER staff members and had to have her legs pinned down by the doctor on duty. She was then restrained to the bed by the ER staff. While at the ER the suspect claimed to have been sexually assaulted, she was not specific on the details when questioned. She claimed the incident occurred with multiple others present who were on scene when I arrived and did not inform me anything occurred. I had the ER staff have a sexual assault nurse speak to the suspect on the phone, I was informed by ER staff the nurse stated she was to intoxicated to be tested and they would speak to her after she is discharged from jail. The suspect was cleared for jail a short time later. Outside the ER I talked to the suspect while I let her smoke, she told me that she had been prescribed medication for depression. She also said that she had been using Xanax previously. She told me her husband had been utilizing Methamphetamines and he had sexually abused her in the past. The suspect was then transported to KCDC, without incident.

All evidence collected on scene was taken back to KCSO placed in Best Kit B318048 (100 pills) then turned over to the evidence custodian.

**Primary Narrative By Johnathan Goldsmith, 05/25/20 02:57**

I was called by dispatch, asking if I could assist the City of Camden officer who was on the way to the jail, with a suspect who was resisting/ fighting with officers at the time of arrest. I arrived at the jail to assist City officer Kelly with the suspect, she already had the suspect inside the Blood Alcohol room. She informed me the suspect had attempted to kick her when she placed the suspect in her vehicle. She also told me the suspect was extremely intoxicated and was not obeying commands. Officer Kelly Was attempting to get the suspect to listen to her while she explained the implied consent rights. I assisted officer Kelly in getting the suspect out of the B.A. room, once she had finished her examination. The suspect would not comply with commands and attempted to walk past officer Kelly when she attempted to handcuff her. We got the suspect handcuffed in the front of her body, then moved the suspect to the booking door. The detention officer came out and began asking the suspect questions the suspect was completely uncooperative. The suspect began fake coughing at the detention center officer, as she got closer to the officer I turned the suspect around to wall and pinned her against it. We escorted her inside the booking area, as the detention center officer began searching the suspect, the suspect raised her hands and pushed the officer in the head and then swung at her. I grabbed the suspect by the arm and began applying a wrist lock pain compliance. I turned the suspect so she was facing the wall before releasing her once the other officers gained control over her. The officers then let go of the suspect and she stepped in between the officers and delivered a soccer style kick to my groin area. I delivered two close fist strikes too the suspect abdomen which stopped the suspect from assaulting me and she fell down on the floor. The suspect layed on the floor as if she was unconscious, I told her to get up and tried to assist her to her feet, she just layed back on the floor pretending to be asleep. I gave the suspect a series of sternum rubs before she finally started talking, she would swipe at my hands every time I conducted a sternum rub.

The dentition officer then stated the suspect needed to go to the hospital though nothing was wrong with her. The suspect refused to stand up and walk, myself and a City Officer carried her outside into the sally-port, once outside the suspect attempted to kick both of us. Both City Officers pinned the suspects legs down, while I retrieved my hobble restraint from my vehicle. I applied the restraint to the suspect legs, placing the suspect in the Total Appendage position, with her hands in the rear and the hobble connected to the handcuffs so she could not kick officers. We then placed the suspect in the car, then transported her to Kershaw Emergency Room. The suspect was cleared by the ER staff for jail a short time later. After the suspect was cleared for jail, she refused to walk to the vehicle and had to be forced to walk to the patrol cars. She was transported back to KC-DC without incident.

Deputies were called to the suspect's residence at 1403 Red Hill Road 3 times in the matter of about 3 hours. The suspect was highly intoxicated each time and deputies attempted to deescalate the situation every time we arrived. The suspect broke his dining room table the second time deputies arrived on scene causing minor cuts to his arms. The suspect had utilized a baseball bat to break the table and destroy things inside his home. He refused EMS on that occasion, we advised him, not to leave his home due to his level of intoxication. The suspect's mother was on scene and she attempted to get the suspect to calm down and stay inside. The suspect was nearly struck by a car according to the complainant's mother, which is the reasoning why she called law enforcement the second time. The suspect agreed to stay inside and not leave his home prior to deputies clearing the scene.

Units were again called to scene around 1657 hrs for the suspect, the complainant the suspect's mother stated (MP) was highly intoxicated stating he was suicidal and had a firearm. The complainant was able to get the firearm away from the suspect prior to my arrival, to the suspect's mother's house 1330 Red Hill Rd. I observed the suspect staggering along the side of the road, he seemed to still be highly intoxicated. I verbally made contact with the suspect trying to get him to stop walking away from me, he stated he did not want to talk to anyone. The suspect began walking into the roadway at intersection of Red Hill Rd and Seegars Mill. The suspect stopped and began to walk directly at me with his fist clinched ready for a physical confrontation, the suspect then bumped me with his chest trying to push me back. I told the suspect to stop, I grabbed him by his right forearm and placed the other hand on his chest while I spoke to him trying to deescalate the situation. I told the suspect to put his hands behind his back, because of his aggressive actions. The suspect pulled away from me as I attempted to handcuff him. The suspect turned toward me, with his left fist clinched. I grabbed the suspect by his left arm placing it into a straight arm lock (pain compliance) I then advised the suspect he was under arrest. (MP) was still pulling his arms away from me attempting to walk back to his mother's home, he ripped his left arm away from me at that point. I utilized a leg sweep on the suspect laying him on the ground on his stomach, so I could handcuff him. Once the suspect was under control, I removed him off the ground and stood him up on his feet, so that his airway was not obstructed.

Once I removed the suspect from the ground I noticed a small amount of blood on his nose where he had hit his face on the ground during the struggle. I then asked dispatch to send EMS to my location to evaluate the suspect. I read the suspect his Miranda warning, then advised him he was under arrest for Public Disorderly Conduct as well as resisting arrest. He stated he did not want to speak to me. EMS arrived on scene a short time later, the suspect refused to go to the ER and would only let EMS put bandages on the cuts he had already inflicted on himself when he broke the table at his home. EMS cleared the scene and I transported the suspect to KC-DC, without further incident.

Dispatch notified units that a suspect who was currently on Face-book live stating he was going to commit suicide had come back into our jurisdiction. Units had already been looking for the same subject nearly 10 minutes prior to his phone being pinged in our jurisdiction. According to the suspect (BF) he had taken up to 30 XANEX pills and drank alcohol. They stated the vehicle was on Hwy 601 near Kinard Rd. I was already in the area when dispatch notified they were tracking the vehicle going to the intersection of HWY 1 and HWY 34. I turned around attempting to locate the vehicle, a blue in color Dodge Durango plate (RCH436). I caught up to the vehicle near the Wateree River bridge. The vehicle was in the number 2 lane moving well under the speed-limit. Two other vehicles were around the vehicle so that officers could easily locate it. I initiated a traffic stop on the vehicle at US-1 and the entrance to the boat ramp, where the suspect turned off onto the entrance of the boat ramp and continued down toward the river.

The suspect failed to yield, so I activated my sirens to get him to stop, he did not. The suspect continued driving under the bridge in the direction of the river. One of the vehicle's following behind the suspect, had someone who was later identified as his wife (KF), began chasing after the vehicle on foot in order to get him to stop. The suspect finally came to a stop underneath the bridge, (KF) was beating on the window of the vehicle. I pulled my vehicle up to the rear left tire of the vehicle so that he could not pull away. I got out of vehicle and observed the suspect with a wooden box in his lap. He was consuming multiple different pills all at once. I asked him multiple times to unlock the door before I asked the shift Lt for permission to break the window to prevent suspect from committing suicide. The Lt advised me to break the glass to prevent the suspect from getting back on the roadway. I utilized my impact weapon to break the glass on the drivers side window of the vehicle. As I was breaking the glass, dispatch advised the suspect maybe armed. I reach into the vehicle unlocking it and opening the door. Once the door was open, the suspect made a motion to get something from in between the seat. I grab the suspects arm pulling him from the vehicle, while giving him loud verbal commands to go to the ground. I layed the suspect on his stomach before attempting to handcuff him for his and my safety. The suspect began to resist being handcuffed. I was able to take the suspects back and control his posture to keep him down on the ground. I gave him commands to stop fighting and give me his hands, which he did not comply with me commands and continued resisting being handcuffed. I then put my left arm under neath his left shoulder, to prevent him from being able to push off the ground. I then pulled his left arm in the direction of his face so I could connect my hands and apply an arm and should compression. I flatted the suspect out on the ground then advised one of the witnesses standing by watching the incident to let dispatch know what was going on from my car radio. The suspect continued to resist, though I had him on his stomach flattened out. He was still attempting to use his arms to push up and get on his feet. I then brought my right arm across his mouth and nose, connecting my hands together across the suspects face, before applying a pain compliance technique. The technique was successful in getting the suspect to comply and give me his hands. Dep. Miles showed up on scene at that moment and we placed the suspect in handcuffs.



We removed the suspect from the ground so his airway was clear and then placed him in the back of my vehicle after searching him for weapons. We began a search of the vehicle, locating XANEX pills inside and outside of the suspect vehicle. We then realized the suspect had left his vehicle in gear and it rolled back striking my patrol vehicle causing minimal damage. The suspect began banging his head on the back glass of my vehicle attempting to harm himself further, so I removed the suspect from the vehicle and placed the Hobble restraint on his legs to demobilize him. EMS, the shift supervisor and Highway patrol arrived on scene soon after. The suspect was taken out of my vehicle and turned over to EMS, where he told EMS he had taken up to 30 XANEX pills. We continued our search of the suspect vehicle locating a wooden box containing a baggy of marijuana weighing .8 Oz, the baggy was placed in evidence to be destroyed. A sum of money was also located in the vehicle which was counted in front of (KF) and given to her. The suspect was transported to KC-ER, and units cleared the scene after SC-HP completed an incident report to the damage to my vehicle. The suspect vehicle was towed from the scene by Roy Kelly's.

Deputies Johnson and Goldsmith went to the suspect residence 911C Highway 1 North in Cassatt to affect a lawful arrest, on warrant number 2020A2810100624 CRIMINAL SEXUAL CONDUCT IN THE 1ST DEGREE. We knocked on the door of the residence and the suspect NE came to the door and spoke to Dep. Johnson. The suspect NE stated KG was not home but he was at work, the suspect NE refused to let deputies search the home for the suspect. I could hear footsteps inside the residence while she was outside speaking with us, Dep. Johnson explained to her that if she was hiding the suspect KG, she could possible be charged with hindering if she aided him. The suspect NE then went back inside the home, the suspect KG then came to the window and began speaking to myself and Dep. Johnson. We informed the suspect we had a warrant for his arrest at that point. The suspect KG stated he needed to call his lawyer then change clothes, we informed him to come outside and we would allow him to make a phone call. The suspect went back inside the residence, and I went to to the front door. I began knocking on the door to get them to open it, the suspect NE eventually opened the door. NE was very uncooperative stating she had to change clothes first, she stood in the doorway to slow me down from seeing the suspect who was attempting to flee out the both door. Dep. Johnson was able to climb through the window, the suspect had opened earlier and caught up to him on the back staircase.

The suspect KG was still uncooperative refusing to let Dep. Johnson handcuff him, stating he needed to use the phone. As soon as we touched the suspect he began fleeing on foot, down the stair case and around to the front side of the house. The suspect tripped over his own feet and fell to the ground, the suspect immediately hopped up and grab my arms in order to prevent me from being able to arrest him. The suspect was still holding my arms while he was attempting to flee, I delivered a knee strike to the suspect in order to break his grip on my arms. Dep. Johnson went around behind the suspect and secured him around his waist, the suspect was still actively resisting Dep. Johnson, and Myself took the suspect down to the ground. The suspect rolled onto his knees refusing to allow us to handcuff him, he was trying to stand up and get back to his feet. I delivered two closed fist strikes to the suspects abdomen which had little effect on the suspect. The suspect NE came over to the immediate area around deputies and began shouting/getting in the way of deputies forcing us to draw our attention to her and not the suspect KG, while we where actively attempting to take him into custody. I was able to secure to suspect KG right arm and placed it into a straight arm lock, I then told NE to get away from deputies because she was causing us to split our attention between her and KG. I told NE 2 times at that point to get away, she did not, while I was distracted with telling her to move away KG was able to rip his arm away from me and put it underneath him. Once the suspect got his arm underneath him, he began pushing away from the ground attempting to get back to his feet. I utilized a back mount in order to prevent him from being able to use his legs, and get up to his feet. The suspect was however to roll onto his right-side and fight with Dep Johnson to get his left arm away from him which Dep. Johnson was attempting to handcuff. Do to the suspect still actively resisting I drew my Electronic Control Weapon and placed it into the drive stun mode. NE was still in the immediate area around the suspect yelling at deputies not to tase him, I activated my ECW and applied it to the suspects back. The stun had no effect on the suspect and he was able roll over and disconnect the stun. I then placed it on his bicep and activated the ECW again in stun mode KG was able to push it away with his opposite hand, the suspect then grabbed the hand I had the ECW in, to prevent me from using it on him. I attempted to apply the ECW 4 more times to the suspect though he was able to push it away every-time. I told the suspect NE once again to go away, who was now standing directly above my head while we attempted to make the arrest, she said that "I could not tell her to go away she was going to stand right there".

The ECW was having little to no effect on the suspect, so I moved to a different option, I removed my Vexor MK-3 pepper spray from the holster. Dep. Johnson was still talking to the suspect attempting to get him to comply with our commands. Neither suspect was complying with our commands at that point, we were able to get a handcuff on his left arm though he was able to break the grip and put his hand back underneath his body. I then deployed my pepper spray to the suspects face to stop him from resisting, the suspect NE who was still standing in the area around deputies yelling and distracting us from KG. I turned the pepper spray in her direct and deployed it at her at that point. She then began to back away from us, and we were then able to handcuff the suspect KG with his hands to the rear. We then removed the suspect from the ground so his airway was clear and walked him to Dep. Johnson's vehicle. I then placed NE under arrest and placed her inside my vehicle. We notified dispatch we had two suspects in custody and asked for EMS to meet us at our location. Both suspects were complaining that the pepper spray was burning their eyes, I got both suspects a bottle of water and myself and Dep. Johnson assisted them in washing out their eyes. I then escorted NE over to a water hose behind the home so she could further wash off her face. The shift supervisor and EMS arrived on scene a short time later and aided both suspects in decontaminating their face. Once both suspects were clear from EMS they both were transported to KC-DC without incident.

On this date the suspect Micheal Tyler Davis was stopped, by Deputies operating white in color Toyota Avalon 4 door

temp tag (AB0423A).

The suspect was sitting on the ground in front of the deputies vehicle, as I arrived on scene. I noticed a orange in color pill bottle with a white in color substance inside clear plastic baggies. The bottle was laying under the deputies vehicle within arms reach of the suspect. I advised the deputy of my findings and I detained the suspect with his hands to the rear. The suspect is a white male approximately six foot one inches around 175 pounds. The suspect was wearing a black and red Chicago Bulls hat with a plain white T, Khaki. shorts and black red and white sneakers. The suspect had a Red 6 pointed crown with the words King tattooed above it. The suspect was very uncooperative the entire time. I removed a brown in color leather wallet from the Davis back right pocket, there was a clear plastic baggy of a white crystal like substance believed to be meth inside the wallet. I continued searching the suspect to find out if he had anymore narcotics hidden on his person, when he began pulling away in the direction of the open drivers door. When I attempted to check the suspect crotch if he had hidden anything between his legs he would clench up and pull away. I had to push the suspect against the vehicle to stop him from pulling away when I tried to search him. I eventually escorted him to my vehicle and placed him in the cage.

We located rounds for a possible rifle in a bag hidden inside the suspect vehicle. I asked him if he was affiliated with the I-G-D he looked at me annoyed and stated he doesn't gang-bang. When I asked him about the crown on his arm, he stated do I know anything about any of that. I asked him again if he was a GD, he stated no-one told me that he was a gang member. The suspect denied being a member of the Gangster Disciples though deputies had been informed, he was a member and his clothing resembles being involved with a gang. The suspect had in his possession enough methamphetamines for possession with intent to distribute, along with the unknown blue pills he had within the same bottle which held the methamphetamines.

Units were dispatched for a subject who stated she had been choked by her wife, the complainant stated they were at the Hyco Baptist Church. Ems was already in route to check on the complainant. I arrived at the church locating none, dispatch informed me the complainant was out with EMS and they were about to start fighting. I located the complainant and the suspect at the Dollar General on Black-River Ave. The suspect was there yelling and cursing at the complainant with EMS attempting to separate them. I began speaking with the suspect, though she continued to yell and curse at the suspect, in front of the business with other on lookers present. I told the suspect to calm down and walk to my patrol vehicle, so I could talk to her, the suspect stop yelling momentarily then began yelling and cursing again. The suspect had a strong odor of alcohol on her breath and person. I again told the suspect to calm down and speak to me, she did not. I handcuffed the suspect with her hands to the rear, and informed her she was under arrest for public disorderly conduct.

I placed the suspect in my vehicle, and she almost immediately began kicking and banging the doors and cage in by vehicle. I told the suspect if she continued she would be restrained, she stated she "didn't give a fuck, do it". I had my back deputy hold the suspect while I placed the hobble restraint on the suspect's feet. While I was placing the restraint on her feet the suspect continued resisting not allowing me to restrain her feet, the suspect also kicked me while I attempted to restrain her legs. I applied the mandibular angle to get her to stop. Once the restraint was on her feet we sat the suspect up so her airway was clear, though she continued disobeying commands. She kicked the restraint off her feet before I could secure it. We then began placing the seat belt on the suspect for her safety when she began pushing away toward my back-up officer, so I could not get the seat belt on her. I pulled her back over multiple times, though she would push away so she was not restrained inside the vehicle. The suspect snatched her shoulders away and was pushing off the floor in my vehicle to avoid being placed in the seat belt, I then placed my elbow in the suspect's shoulder pressure point to get her to stop resisting. The suspect stop resisting and agreed to calm down. I released the pressure on her shoulder and seat belted her in. The suspect was then transported to KC-DC.

Once at the detention center the suspect continued her behavior though she was warned multiple times, she tried to snatch away from me as I transported her into the booking area. She would not listen to detention center officers either. She began banging on the cell, before she began to undress in the cell. The detention center officers then placed the suspect in the restraint chair. I cleared the detention center soon after. The suspect does have a prior history for resisting arrest and assaulting law enforcement.

Units were called to the above addresses for an intoxicated driver the complainant stated the suspect left in her car without permission and was intoxicated. The complainant stated, she wanted her car back at the location. I arrived on scene and spoke to (PM) who stated her live-in boyfriend, took her car without permission and he was highly intoxicated. The complainant stated the suspect co-signed for the vehicle and she was the primary owner. She stated the suspect likes to drink and drive alot. The complainant showed me a picture of the vehicle on her phone with the tag number displayed, I ran the tag on the vehicle which came back to the complainant. (PM) stated (RS) was a few houses down on Love Rd, she asked, could I escort one of the boys from the house to get the vehicle. (PM) was worried the suspect would continue to drink and drive if he had the vehicle in his possession. The complainant could not drive the vehicle her self due to a knee injury. I escorted the complainants son and his friend, three houses down from the complainants address where the vehicle was parked. As I pulled up to the location the suspect shut the door and leaned up against the car. I began speaking to the suspect when, I noticed he was extremely intoxicated, the odor of alcoholic beverage on his breath and person, the suspect also was unsteady on his feet. I explained to (RS) that (PM) wanted her car back and, I explained that he was intoxicated and he could not drive the vehicle, the suspect stated he was not drunk he had a few beers but he was not drunk.

The suspect was stalling not wanting to allow the individual the complainant sent to take the vehicle. (RS) stated he didn't have a key for the vehicle though I saw him, get out the vehicle. The individual who came to get the vehicle got inside the vehicle and took control of it, the suspect became extremely angry arguing about who owned the car. I explained to him multiple times the complainant wanted the vehicle and he took it without her permission and he was too intoxicated to drive. The suspect continued being belligerent yelling and cursing then he walked over to the passenger side door after he told me hold on, he aggressively started pulling on the door. I was unsure what the suspect was attempting to retrieve from the vehicle, so to keep him from being able to gain access to weapons, I told him to move away from the car. The suspect still didn't move away from the car, so I pushed him away from the door with both hands on his chest, I then told him to walk toward my vehicle so he would calm down. When the suspect began walking he intentionally elbowed me in the chest, I then grabbed him by the arms so I could control his posture and escorted him to my vehicle. I leaned him against my vehicle until he calmed down, then I let him go. I then explained to the suspect the complainant wanted the vehicle and he was too intoxicated to drive, I explained to him he could ride with the individual the complainant sent to get the vehicle. No one was taking the vehicle from him, it was just going to be returned to the complainants address with a sober driver. The suspect calmed down for the most part, then walked over to the vehicle and got in the passenger side door. The suspect then asked for my name, which I gave to him deputy Goldsmith, which he was not happy with. I then escorted the vehicle back over to the complainants addresses, and spoke to (PM), she was sure (RS) would begin causing a problem once I left. She even requested, that I drive slow so I could make it back quickly. I cleared the scene soon after.

I arrived on scene of a suspicious vehicle in the Abney Church parking lot, the vehicle was Grey in color parked on the side of the Church closet to Roberts Rd. I approached the vehicle, exited and made contact with the suspect (TS),



who was sitting in the driver's seat. The suspect immediately exited the vehicle, though he was not told to do so. The suspect began stating he was on his way home. I could clearly tell the suspect was under the influence. The suspect was unsteady on his feet swaying back and forth. The suspect had his left hand in his pants pocket, which I asked him to remove his hand, he complied, and then began calling people on the phone. He stated he was almost home pointing in the direction of where he lived, which is very common when a suspect is trying to divert my attention from themselves. The suspect had a strong odor of alcoholic beverage coming off his breath and person. I noticed the suspect vehicle had obvious fresh damage from him colliding with something on the roadway. I began conducting a pat-down search of the suspect for weapons. While patting the suspect down, I noticed a holster or a firearm laying on the front passenger seat. I had the suspect bring his hands behind his back to detain him due to his level of intoxication and the possible presence of a firearm.

The suspect brought his hands behind his back, though he kept saying no when I began putting handcuffs on him. The suspect quickly ripped his right arm away from me to the front of his body. I told the suspect to give me his hand. The suspect began to pull away in the direction of his vehicle, while pulling up his elbow as if he wanted to strike me. I also believed the suspect may have been armed. I delivered a strike to the suspect's neck and shoulder which stunned him and I tripped the suspect taking him to the ground. Once the suspect was on the ground, I gave him loud verbal commands to give me his hands. The suspect did not comply with my commands and was pushing against me attempting to get to his feet. I delivered a closed fist strike to the suspect's abdomen while giving him loud verbal commands. The suspect was still resisting/fighting me. I then delivered a closed fist strike to the head and neck area attempting to incapacitate the suspect. The first strike was ineffective. I delivered a second closed fist strike to the suspect which rendered the suspect unconscious. I then radioed to dispatch, that I had the suspect in-custody and that he was fighting me. I then sat the suspect up who was already awake and alert. The suspect was bleeding from his mouth, he also had some trouble walking because of his level of intoxication.

I escorted the suspect to my vehicle to search him. The suspect would not sit in the vehicle and I had to forcibly place him inside the vehicle after asking him numerous times to get in the vehicle. I was trying to keep my attention on the vehicle, where I believed the firearm was sitting and unsure no one else was on the scene with the suspect. The initial call stated there where two vehicles in the parking lot. I pushed the suspect again into the vehicle, though he was fighting to get back to his feet. The suspect was kicking me trying to get to his feet. I gave the suspect multiple warnings to get into the vehicle before I pushed the suspect down on the seat trying to restrict his movements. The suspect stated he would stop fighting and would comply. By this time, I realized the suspect was extremely intoxicated on much more than alcohol. I believed the suspect was also under the influence of some type of narcotics. He was extremely sweaty as well as aggressive. When I let the suspect go and told him to place his feet inside the vehicle, he sat up and attempted to get up on his feet again. I continued giving the suspect loud verbal commands which he did not adhere to. I removed my Conducted Electrical Weapon, put it into drive stun mode and delivered a stun to the pressure point on the right side of the suspect's neck. The stun only momentarily stopped the suspect from fighting. I then told dispatch to have the Code Enforcement who called to come back to the scene. While the officer was en-route back to my location, I was still fighting with the suspect trying to prevent him from getting back to his feet. I removed my OC sprayed gave the suspect warnings before spraying the suspect, which had little to no effect at all. He was still attempting to get to his feet, fighting with me. I removed my impact weapon, prepared to deliver strikes to the suspect's legs, when the code enforcement officer showed back up on the scene. The Officer came up and double checked the vehicle was cleared of any additional suspects and the firearm was secure. The suspect began to get extremely tired at that point and I was able to hold him in place. Ems arrived on scene and began to speak to the suspect. It was at that point, we realized the suspect had lost a few teeth, which EMS collected.

The suspect was still extremely belligerent, not listening to commands. The suspect was placed in the ambulance, though I had to restrain his legs because he kept attempting to get up. Before the suspect was transported to KERSHAW ER, Lt. Boykin arrived on scene and took control of both mine and the suspect vehicle. He located a baggy of multi-colored pills sitting just inside the suspect vehicle. The pills looked to be Ecstasy (MDMA). There were also multiple open containers of alcohol inside the vehicle. I informed the EMS personnel that he was probably under the influence of the drug as well as alcohol. The suspect was transported to KERSHAW ER without incident. The suspect was subsequently cleared by ER staff. He was then transported to KCDC. The evidence collected on scene was taken back to KCSO and placed into Best Kit B327433 (77 suspected MDMA pills) and placed into drop box 21.

Units were called to the above addresses for a Domestic, the complainant stated the suspect (VH) was armed and had fired the weapon inside the home. The complainant stated the suspect should still be at the home, she also believed the suspect was under the influence of narcotics. The complainant left the scene prior to calling 911. In route to the call, I spoke with my back-up officer, who informed me the suspect who he was familiar with was out on bond for attempted murder. Near the location myself and my back-up officer meet up, and went to the residence together, we had dispatch clear the channel once we where on scene. We utilized or pa system and our patrol rifles, to call out the suspect from the home, there was another suspect a young black male (MM) standing by the shed in the back yard. We began giving him commands to come out when the suspect (VH) exited the residence, the suspect was wearing a black shirt and jeans when he came out carrying a second shirt in his hand. I asked the suspect who came out of the house, if he was (VH) he stated he was, we called the suspect over to us and detained him with his hands to the rear. We then let dispatch know that we could now continue normal traffic on the radio. I then escorted him over to the front porch of his home and asked him what occurred earlier on. He began stating he didn't do anything and he could have left if he did something.

He stated they where just fussing thats it, He said he did not put his hands on her. He stated the victim was mad because he came home late the night prior, and they started arguing, and that was it. He stated she knows he is out on bond so the victim, uses that to her advantage. He stated the incident occurred throughout the house, he didn't state a specific room at that time. I walked through the home, there was no obvious damage inside the home that I could see. I looked through all the rooms for signs of a struggle. It wasn't until myself and my supervisor looked through the home, did we see small pieces of wood laying on the table. We also located small drops of blood on the floor near the table. Near the sliding door there where more pieces of board which had been broken, off something but we where not sure from what. As I was walking out the door, I noticed a trash-bag sitting near the washing machine, with larger pieces of the wood laying on top of all the other trash in the bag. With the blood on the floor and the broken materials in the trash, proved there was evidence an altercation occurred. The suspect stated the argument was only verbal, it was evident the suspect had cleaned up scene prior to deputies arrival. We brought the suspect inside the residence to talk to him, once inside the residence the suspect still wouldn't admit to anything happening. We read the suspect his miranda warning and he stated he wanted to speak to us. The suspect finally stated he was the victim, and the complainant was the suspect, he stated they argued about him coming home too late, and the complainant went and got a gun from the room. The suspect stated the complainant pointed the firearm at him and they fought over the handgun and it fired into the floor. The suspect declined to tell us where in the floor was the bullet strike.

Back-up Officers meet with the victim and got her statement, she informed deputies that the suspect is the one who



had a firearm. She stated he fired 3-4 shots inside the home. The suspect decided to place a call to his attorney while he was sitting at the table, we unhand-cuffed the suspect so he was able to do so. Once the suspects attorney was on the phone, his attorney stated the suspect would not be making any additional statements. Our supervisor returned from speaking to the victim, me then moved the cabinet locating a fired projectile underneath the cabinet. The suspect then uttered didn't shoot the gun its was his wife, we informed him that his attorney had invoked his right to remain silence. The suspect then said, he wanted to talk, he said he agreed to talk after we read him miranda and he still wanted to talk now. He stated the victim and him wrestled over the gun which is how he cut his finger and it fired into the floor near the cabinet. He took the gun from the victim and threw it against the wall near the painting on the wall. After the suspect gave his statement, we deiced to place him under arrest for domestic violence , he was then transported to KC-DC without incident.

## **Supporting Narrative By Brandon Hudson, 10/25/20 10:11**

On 10/25/2020 at 0820 hours Dep J Goldsmith, Dep G Johnson, and I were dispatched to 1884 A Kershaw Hwy in reference to a domestic issue. While I was in-route Dep J Goldsmith and Dep G Johnson had VH (subject) detained at the scene.

I met with PH (victim) at DeKalb Baptist Church. At this time, it was raining so, I asked PH (victim) to sit in my vehicle. She said for the last 3 or 4 weeks he been on drugs and showing out. This morning PH (victim) was sitting on the coach in the living room and VH (subject) wanted to get their son's Honda Accord to drive. She told him no because it is in her name. VH (subject) starting getting enraged and picked up a round item on the coffee table and throwing and breaking it. He then flipped the coffee table over. She states that her cousin MM (witness) is there and saw the whole thing. VH (subject) told her that she is a "bitch, he's leaving, and he going to burn the house down". He turned all the eyes on the stove on and he stated again "I'm going to burn this bitch down". That when she got up went to her room to get her keys and her phone to leave the house. VH (subject) was throwing the table and chairs around. Before she could leave he got into a fight with her taking the keys from her. He took the keys off of the ring and she could not find her cart keys. While she was looking for the keys VH (subject) went to his room and come out with a gun. That when she tried top call 911 but VH (subject) took the phone from her. He tried to fire the gun but it misfired. He kept telling her "that he was going to kill her, I going to kill you bitch". He also kept telling her that "he was going to burn this bitch down". She was trying to cut the stove off and VH (subject) grabbed a tablet type item and hit her across the face with it. Her cousin MM (witness) was behind the shed in the back yard. She yells out of the back door for MM (witness) to come get him. MM (witness) came into the house trying to calm VH (subject) down. She stated that VH (subject) fire the gun four or five times. MM (witness) was able to fine PH (victim) car keys on the floor and gave then to her. She left the scene and called 911 while driving from the house. PH (victim) wrote a statement of this interview.

I asked PH (victim) what kind of gun did VH (subject) have? She states it was a 38 the same kind of gun that they use at the prison. I asked her if it was a revolver? She said yes. I asked her what color was it? She said it was a silver gun with a brown handle. It was asked of her where the gun was laying? She states that it was on the ground in the front yard by the steps. She was also asked where the gun was fired? She states that VH (subject) fired it in the kitchen in front of the chain cabinet. She was asked if VH (subject) pointed the gun at her? She states that she was scared and then she said yes.



I did not see any injuries to PH (victim). I did take pictures of her that I will add to this report. I also explained that VH (subject) was under arrest from Domestic Violence. I gave and explained the victim's notification form to her.
