**Section Title: Reason for Separation**

**Type description of the alleged misconduct::**

Johnathan Goldsmith was terminated from the Kershaw County Sheriff's Office for his involvement in a use of force incident on 10/15/2020 (ref: KCSO Case# 2020-3814). He apprehended a heavily intoxicated subject who resisted arrest. Goldsmith took the subject to the ground while striking him multiple times with a closed fist. This caused the subject to lose three teeth and rendered him unconscious. After handcuffing the subject, Goldsmith then walked away while failing to immediately render medical aid or calling for medical assistance. After he did call for an ambulance, Goldsmith then made the decision to use additional force to attempt to place the subject in the back of his patrol SUV. It is our belief that medical assistance should have been called immediately, the subject should not have been left unattended after being knocked unconscious and bleeding from his mouth, and that there was no reason to continue using force on the wounded subject in order to put him in a patrol car to wait for an ambulance to arrive on the scene. A criminal investigation on Goldsmith is currently in progress by the SC State Law Enforcement Division (SLED).
