DESCRIPTION OF OFFENSE: Assault / Assault & Battery 3rd degree

I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

On May 24, 2020, Johnathan Lewis Goldsmith, while employed as a deputy sherriff with the Kershaw County Sherriff's Office(KCSO) did willfully and unlawfully commit the crime of Assault and Battery 3rd degree against the victim, [REDACTED]. During booking at the Kershaw County Detention Center(KCDC) [REDACTED] was demonstrating noncompliance with jail staff. [REDACTED] turned and raised [REDACTED] right foot and delivered a strike between Deputy(Dep) Goldsmith's legs to his groin area. Dep. Goldsmith delivered two closed fist strikes with his right arm to the abdomen of [REDACTED]. [REDACTED] fell to the floor. Facts to establish the above charge against the defendant, Johnathan Lewis Goldsmith, are based on witness statements, KCDC video footage, and the defendant's incident report. All this done against the law, peace, and dignity of the State of South Carolina.
