**Narrative**

ON 9/4/24 DEPUTIES RESPONDED TO 45 MCKISSICK DR LOCATED IN THE PAWLEYS ISLAND SECTION OF GEORGETOWN COUNTY IN REFERENCE TO A DOMESTIC IN PROGRESS.

ON SCENE I ADVISED CENTRAL TO STAGE EMS DUE TO CAD NOTES AND I THEN MET WITH THE OFFENDER AND ASKED WHAT HAPPENED TONIGHT. THE OFFENDER STARTED TO SLUR HIS WORDS AND STATED NOTHING HAPPENED TONIGHT JUST A VERBAL ARGUMENT. I THEN ASKED THE OFFENDER WHERE THE VICTIM WAS LOCATED INSIDE THE RESIDENCE. THE OFFENDER STATED IN THE SECOND BEDROOM ON THE RIGHT. I THEN ENTERED THE RESIDENCE AND I FOUND THE VICTIM LAYING IN THE BED COVERING HERSELF. I THEN STATED TO THE VICTIM I AM DEPUTY BURNS WITH THE GEORGETOWN COUNTY SHERIFFS OFFICE. THE VICTIM THEN CAME RUNNING TOWARD THE DOOR SAYING SHE WAS SCARED.

AS THE VICTIM APPROACHED ME, I SAW VISIBLE INJURY TO THE RIGHT EYE WHERE THERE WERE VISIBLE INJURY SUCH AS A BLACK EYE AND BLOOD VESSELS POPPED. I THEN ASKED THE VICITM WHAT HAPPENED TONIGHT. OTHER DEPUTIES WERE ARRIVING SO I TOLD THE VICTIM TO SIT BACK IN THE BED UNTIL OTHER DEPUTIES ARRIVED. I THEN WALKED BACK TO THE OFFENDER AND TOLD HIM TO STAND UP AND TURN AROUND. I THEN PLACED THE OFFENDER IN HANDCUFFS CHECKED FOR FIT AND TIGHTNESS AND DOUBLE LOCKED. I THEN ADVISED CENTRAL I HAD ONE DETAINED AND TOLD THE OFFENDER HE WAS BEING DETAINED DUE TO MY INVESTIGATION. I THEN WALKED THE OFFENDER DOWN TO MY MARKED PATROL UNIT AND PLACED HIM IN THE BACKSEAT.

AS DEPUTIES ARRIVED ON SCENE, I CAUGHT THEM UP ON WHAT HAPPENED AND THEY ADVISED TO TAKE HIM TO THE DETENTION CENTER. I THEN ADVISED CENTRAL I HAD ONE UNDER ARREST. DEPUTIES THEN WALKED UPSTAIRS TO THE VICITM LOCATED IN HER BEDROOM. THE VICTIM STATED TO DEPUTIES SHE THREW THE OFFENDERS PHONE BECAUSE SHE FOUND OUT THE OFFENDER WAS CHEATING ON THE VICTIM. THE OFFENDER THEN WALKED IN TO THE BEDROOM AND STRUCK HER IN THE FACE WITH A CLOSED FIST APPROX 3 TIMES. VICTIM THEN WAS ABLE TO BREAK FREE. THE OFFENDER WAS ABLE TO GET BACK AT THE VICTIM AND SHE THEN WAS STRUCK APPROX 2 MORE TIMES IN THE FACE LEAVING VISIBLE INJURY. AT SOME POINT DURING THIS ALTERCATION THE OFFENDER THREW THE VICITMS PHONE AWAY FROM HER WHEN SHE WAS TRYING TO CALL 911.

DUE TO THE INJURY OF THE VICTIMS EYE EMS TOOK HER TO THE HOSPITAL. THE VICTIM WAS UNABLE TO WRITE OUT A STATEMENT FORM AND SIGN THE VICTIMS BILL DUE TO HER INJURY.

I THEN REACHED OUT TO THE VICTIM AND SHE STATED THE DOCTOR TOLD HER SHE POSSIBLY COULD HAVE SOME PERMANENT LOSS OF VISION BUT UNKNOWN AT THIS TIME

PATROL CAR WAS CHECKED BEFORE SHIFT AND AFTER TRANSPORT AND CAME BACK WITH NEGATIVE RESULTS.
