NARRATIVE

ON 9/29/2024 AT 1121 HOURS, I, OFFICER SCHENCK, RESPONDED TO AN ALLEGATION OF HARASSMENT OCCURRING AT 1112 HOURS IN THE PARKING LOT AT SOLID ROCK CHURCH, LOCATED AT 803 HOWARD AVE.

IO 1 ADVISED THAT IN THE PROCESS OF DEPARTING THE CHURCH BY TURNING RIGHT (WEST) ON PAMPAS STREET, PROTESTERS AT SOLID ROCK CHURCH VERBALLY HARASSED HER. THIS INCIDENT OCCURRED AS IO 1 WAS IN HER VEHICLE; THE PROTESTERS WERE ON EITHER SIDE OF THE SIDEWALK. ALTHOUGH THEY WERE IN CLOSE PROXIMITY, THE PROTESTERS DID NOT ENCROACH ONTO THE PARKING LOT WHERE VEHICLES WERE DEPARTING.

IN TOTAL, THE INCIDENT LASTED NINE OR TEN SECONDS.

A MINIMUM OF THREE UNKNOWN INDIVIDUALS ARE HEARD OFFERING UNWELCOMED COMMENTS DIRECTED TO IO 1. I DID NOT HEAR PROFANITY NOR THREATENING STATEMENTS. INSTEAD THE STATEMENTS COULD BE CATEGORIZED AS DERISIVE AND DEMEANING.

IO 1 ADVISED THAT THE DERISIVE COMMENTS INSTILL FEAR IN HER.

THE INVESTIGATION IS ONGOING.
