NARRATIVE

ON 9/29/2024 AT 1121 HOURS, I, OFFICER SCHENCK, RESPONDED TO AN ALLEGATION OF ASSAULT OCCURRING ON PAMPAS DR JUST WEST OF SOLID ROCK CHURCH, LOCATED AT 803 HOWARD AVE.

AT 1121, IO 1 WALKED BRISKLY FROM THE CHURCH PARKING LOT TO MY VEHICLE WHICH WAS IN THE MEDIAN WITH CRUISE LIGHTS ON FOR THE PURPOSE OF DETERRING ESCALATION, BOISTEROUS BEHAVIOR, AND TRESPASS CONCERNS DURING THE COURSE OF PARISHIONERS DEPARTING THE CHURCH WHILE APPROXIMATELY 25 PROTESTERS WERE ON SCENE. I OBSERVED IO 2 QUICKLY APPROACH IO 1 FROM THE EAST.

WHEN IO 2 WAS IN CLOSE PHYSICAL PROXIMITY TO IO 1, I OBSERVED IO 1 USE HIS LEFT ARM TO REPEL IO 2. I CONSIDERED IO 1'S ACTIONS TO BE CONSTITUTED AS DE MINIMIS FORCE AS OPPOSED TO OFFERING OR ATTEMPTING TO HARM IO 2.

IO 2 WAS PROVIDED THE REPORT NUMBER. IO 3 WAS PROVIDED BOTH THE REPORT NUMBER AND GUIDANCE REGARDING FUTURE CORRESPONDENCE WITH LAW ENFORCEMENT.

NO INJURIES WERE OBSERVED NOR ALLEGED. IO 1 AND IO 2 DENIED EMERGENCY MEDICAL SERVICES.

THE INVESTIGATION IS ONGOING.
