SLED CHARGES RICHLAND COUNTY MAN WITH ACCESSORY TO ATTEMPTED MURDER

Agents with the South Carolina Law Enforcement Division (SLED) charged Daniel Eugene Hutto II, 20, of Columbia, SC, on June 12, 2023, with Accessory before the fact to Attempted Murder.

On March 2, 2023, SLED Low Country Region was requested by Chief Timothy Taylor of the South Carolina State University Police Department (SCSUPD) to investigate a shooting incident that occurred at a party on campus.

Details can be found in the attached warrant.

Hutto was booked at the Orangeburg County Detention Center.

The case will be prosecuted by the 1st Circuit Solicitor's Office.

AFFIDAVIT

SLED Case# 31-23-0024 Warrant#

Personally appeared before me, a magistrate of this county, one Special Agent Jarius Richardson of the South Carolina Law Enforcement Division (SLED), who, first being duly sworn, deposes and says that defendant DANIEL EUGENE HUTTO II (black male, DOB; within this county and state on March 3, 2023, did violate the criminal laws of the State of South Carolina in the following particulars:

DESCRIPTION OF OFFENSE Accessory - Attempted Murder 16-1-40

The affiant states there is probable cause to believe that the defendant named above did commit the crime(s) set forth, and that such probable cause is based upon the following facts:

That on or about March 3, 2023, at South Carolina State University, County of Orangeburg, State of South Carolina, the aforesaid, one Daniel Eugene Hutto II, did commit the offense of Accessory before the fact (16-01-0040). The defendant did willfully, unlawfully, and feloniously aid in the commission of a felony, namely Attempted Murder (16-3-29) by providing the co-defendant with a firearm which the co-defendant then discharged into a crowd of people. injuring at least one person.

The facts to establish the aforementioned are that, in an interview conducted by SLED Special Agent Richardson, the defendant confirmed he was involved in an argument on South Carolina State University Campus. Shortly after the argument, the defendant provided a firearm to the codefendant by opening his book bag allowing him to obtain a firearm. The co-defendant then discharged the firearm into a crowd of students, striking Surveillance footage of the incident corresponds with the information provided in the interview.

The above information was revealed through the investigation conducted by the South Carolina Law Enforcement Division, all to provide the same against the form of the statue in such case made and provided against the peace and dignity of the state.
