There is also a recording of the entire polygraph exam that was administered to John Hobart Lewis Jr. It begins with the words, "Alright, state your full name for me..." It ends with the words, "And he was there at that game." There are no breaks in the recording. Based upon my training and experience, the recording provides the entire polygraph examination process. At the end of the recording, just as the chart collection was completed, Anthony Hudgins states to John Hobart Lewis Jr.: "We're done, and you did fine."
