MOTOR VEHICLE THEFT

ON THE ABOVE DATE AND TIME I CPL AMMONS, PFC CAULDER, SGT WOODBERRY, DETECTIVE G. PIKE, AND DETECTIVE D. ROGERS RESPONDED TO 4 HWY 908, GRESHAM SC IN REFERENCE TO A BREAKING AND ENTERING IN PROGRESS WHERE THE COMPLAINANT WAS ASSAULTED AND THE SUBJECT WAS STILL ON SCENE. PRIOR TO ARRIVAL, DISPATCH ADVISED DEPUTIES THAT A BLACK SUBJECT STOLE A WHITE GMC 1500 PICKUP BELONGING TO NEIGHBOR OF VICTIM#1. THEY ADVISED US, SUBJECT LEFT TOWARD HWY 41A FROM HWY 908. DEPUTIES SEARCHED THE IMMEDIATE AREAS LOOKING FOR THIS PICKUP TRUCK AND I CPL AMMONS WENT TO THE COMPLAINANTS RESIDENCE OF HWY 908. WHILE GATHERING INFORMATION FROM VICTIM #1, A NEIGHBOR WHO WAS ALSO LOOKING FOR THE PICKUP TRUCK CAME UP AND ADVISED ME THAT THE SUBJECT WAS SEEN IN THE STOLEN TRUCK AND HE WAS AT THE PARK AND BLOW OFF HWY 378. I ADVISED DEPUTIES THAT THE SUBJECT WAS AT THE PARK AND BLOW AND I CPL AMMONS RESPONDED AS WELL. THE SUBJECT IDENTIFIED AS ROBERT LEE WILLIS JR WAS APPREHENDED IMMEDIATELY. THE PICKUP TRUCK WAS RECOVERED AT THE PARK AND BLOW AND WAS TURNED OVER TO VICTIM #2. SUBJECT ROBERT LEE WILLIS JR WAS TRANSPORTED TO THE MARION COUNTY DETENTION CENTER BY PFC CAULDER AND SGT WOODBERRY FOLLOWED BEHIND. I CPL AMMONS RESPONDED BACK TO HWY 908 TO FINISH GATHERING INFORMATION. VICTIM #1 STATED WHILE COMPLETING HER WORK ON HER COUCH SHE NOTICED A BLACK OR

DARK IN COLOR PICKUP PULLING IN [REDACTED] DID NOT THINK ANYTHING OF IT AT THIS TIME DUE TO THINKING IT WAS SOMEONE BRINGING BUILDING MATERIALS FOR A WORKER WHO WAS ALSO AT HER HOME. SECONDS LATER THE REAR DOOR OPENED AND SHE OBSERVED A BLACK MALE ENTERING THROUGH HER LAUNDRY ROOM AND HE STARTED APPROACHING HER. VICTIM#1 [REDACTED] STATES THE SUBJECT WAS STILL APPROACHING HER SLOWLY AFTER HE WAS TOLD TO STOP, AND [REDACTED] THEN STATED TO THE SUBJECT LETS GO OUTSIDE THE FRONT DOOR AND TALK ABOUT IT. VICTIM #1 [REDACTED] STATED SHE OPENED THE FRONT DOOR AND THE SUBJECT CLOSED IT AND THEN STARTED CHOKING HER WITH HIS TWO HANDS. VICTIM#1 TRIED TO GET LOOSE AND SUBJECT RIPPED HER SWEATER AND PULLED BOTH THE SWEATER AND T-SHIRT OFF OF HER. THE WORKER [REDACTED] OFTEN CALLED [REDACTED] CAME IN AND WAS ABOUT TO HIT THE SUBJECT WITH A CHAIR. THE SUBJECT TURNED AROUND AND STARTED GOING AFTER HIM [REDACTED] STATED HE WAS ABLE TO GET THE SUBJECT OUTSIDE AND HE AND VICTIM#1 [REDACTED] THEN LOCKED ALL THE DOORS. AT THIS TIME THE NEIGHBOR VICTIM#2 DROVE UP AND SEEN THE SUBJECT TRYING TO GET INTO HIS DARK PICKUP AND DRIVE OFF, SO VICTIM#2 PARKED DIRECTLY BEHIND HIM IN HIS WHITE 2018 GMC PICKUP BEARING SC TAG# [REDACTED] BLOCKING THE SUBJECT IN. THE SUBJECT THEN GOT OUT OF HIS TRUCK BEING A DOGE RAM 1500 BEARING SC TAG# [REDACTED] AND STARTED WALKING AROUND THE HOME. VICTIM#2 WALKED INTO THE RESIDENCE AND THAT IS WHEN SUBJECT IDENTIFIED AS ROBERT LEE WILLIS DROVE OFF IN VICTIM #2 [REDACTED] TRUCK. THAT IS WHEN COMPLAINANT / VICTIM# [REDACTED] TOLD DISPATCH THAT THE SUBJECT STOLE HER NEIGHBORS TRUCK. DETECTIVE G. PIKE AND D. ROGERS ARRIVED AND CONDUCTED THEIR INVESTIGATION. I CPL AMMONS FINISHED WITH THE VICTIMS FORMS AND I CALLED FOR A TOWING SERVICE TO PICKUP THE SUBJECTS VEHICLE FROM THIS ADDRESS OF [REDACTED] HWY 908, GRESHAM SC. STEVENS TOWING ARRIVED SHORTLY AFTER AND PICKUP THE SUBJECTS VEHICLE WHICH WAS DRIVEN UP TO [REDACTED] HWY 908 BY THE SUBJECT ROBERT LEE WILLIS JR. SUBJECT DID ALSO TAKE A BLUE TUB CONTAINING TOOLS OWNED BY WORKER A [REDACTED] HOWEVER THE TUB WAS RECOVERED FROM THE SUBJECTS FRONT PASSENGER SEAT AND RETURNED TO [REDACTED] [REDACTED] STATED HE WAS NOT WORRIED ABOUT THE TOOLS AND DID NOT WANT TO PERSUE CHARGES.
