Ms. Elvis,

I have a critical message that I need to report to the Court and to Judge Arakas. On February 26, 2025 he has 6 pending cases scheduled to be heard with Plaintiff John Paul Miller against Defendants Ally, Melissa Pfeiffer, Nikki Parker, Sandra, Gina Whittington, and Kelly Ohearn.

Mr. Miller has committed a crime in reference to these hearings. He reached out to me and offered an illegal bribe (witness tampering). He is offering to pay me money as well as drop a frivolous lawsuit filed against me (that he filed back in September in Common Plea Court) if I agreed to appear on February 26 and lie under oath providing a false statement against these Defendants. He wants me to say they attack cars, harass him, take pictures of license plates, put license plates online, abuse him and follow and stalk him to every location he goes to. None of this is true and none of it matches what I witnessed at the legally organized protests.

He is demanding that I agree to lie on his behalf and he will pay me, and drop my lawsuit. He is using a lawsuit that I was never served with as a weapon against me to obtain what he wants out of me. Lying under Oath is also a crime. He is not only witness tampering, but offering to pay me to commit a crime. I emailed him back in order to obtain the information he was offering in writing and now I am reporting it to authorities and Judge Arakas.

I am attaching screenshots and printed emails for your reference. I am happy to answer any questions you need, I would NEVER agree to this and I am trying to do the right thing by reporting it to all authorities which is going to increase my risk of being in danger. Please make sure this gets to Judge Arakas!
