On November 9, 2024. Officer Jordan arrested a male subject who resisted arrest. During this event, Officer Jordan used excessive force on the subject while he was handcuffed. Officer Jordan knocked the subject to the ground and pushed his head into the ground several times. Officer Jordan used excessive force on the subject while EMS was attempting to render aid to the subject. Officer Jordan grabbed the handcuffs with his right hand and yanked them upward, while grabbing the subject around his neck and pushing his head toward the ground. Officer Jordan snatched the subject to his feet by his arms and was forcing the subject to walk forward. At this time, several West Columbia police officers intervened and pushed Officer Jordan backwards and took control of the subject.

The Springdale Police Department received two formal complaints from agencies that were on scene of this incident, where they claimed Officer Jordan used excessive force. An Internal Affairs investigation was initiated and Springdale Police Department concluded that Officer Jordan had indeed used excessive force on the subject in this incident. All actions were recorded on body-worn cameras from officers on scene.

There is an active SLED investigation ongoing for officer misconduct stemming from this incident with Officer Jordan.
