On Apr 26, 2023 Deputy Thompson was dispatched to a phone call regarding complaints from Morning Star Church located at 375 Staright Drive, Fort Mill, in the county of York, SC. Nate Degrandpre, who is the safety coordinator at the church, was calling after receiving complaints from parents regarding Erickson Douglas Lee who was a program leader at the church.

Nate stated that in early 2018 Erickson began a program at the church called the Young Special Forces. Erickson pitched this program as a leadership school for young men to help them learn skills and develop team building habits. Allegedly in early 2020 Erickson began taking at least four of these juveniles and providing them a cohort, hosting parties, and performing sexual acts on them. Erickson would allegedly provide oral and digital stimulation to the juveniles, as well as host nude drinking games with the young men. Erickson would host these parties by telling parents that he wanted to take the juveniles out to host a leadership exercise or a camping trip before taking the juveniles to various locations both inside and outside of York County such as at the Morning Star Church, Lee's residence, campsites, and Myrtle Beach. Nate was informed that anything of this nature that occurred outside of York County jurisdiction would also need a police report filed with the appropriate agency. In January of 2023 Erickson's Young Special Forces was dissolved by the church due to separate allegations made by Erickson's mother regarding unrelated issues. Since the dissolving of the group several of the young men have come forward to their parents about the allegations prompting parents to notify the church, who then notified Nate. As much victim, parent, and suspect information as possible has been provided and screenshots of text messages and photos of letters written to Nate have been uploaded to Evidence.com.

Case is administratively closed awaiting further investigation.

The children are juvenile males that belong to a program at the church called Youth Special Forces. The youth leader was identified as Erickson Lee. Deputy Thompson's report lists 4 juveniles currently between 16 & 18 yrs. old.

According to Mr. Degrandpre in early 2018 Erickson Lee began a program at the church called the Young Special Forces. Mr. Lee pitched this program as a leadership school for young men to help them learn skills and develop team building habits. In early 2020 Erickson began taking at least four of these juveniles and providing them alcohol, hosting parties, and performing sexual acts on them. Erickson would allegedly provide oral and digital stimulation to the juveniles, as well as host nude drinking games with the young men. Erickson would host these parties by telling parents that he wanted to take the juveniles out to host a leadership exercise or a camping trip before taking the juveniles to various locations both inside and outside of York County such as at the

Morning Star Church, Erickson's residence, camp sites, and Myrtle Beach. In January of 2023 Erickson was asked to discontinue his involvement with Young Special Forces.

On April 27, 2023 Detective Kinnee was assigned to investigate the reported allegations. In summary, the victims were interviewed by either Det. Kinnee or Sergeant Smith at the Moss Justice Center. The victims provided statements, which indicated Erickson committed acts of Criminal Sexual Conduct with Minors, Disseminated Obscene Material to minors and Contributed to the Delinquency of Minors. These criminal offenses occurred over the course of several years. Erickson regularly provided alcohol to the juveniles and allowed them to consume alcohol until they were sick or passed out. Erickson would motivate the juveniles to drink excessive amounts of alcohol by playing drinking games. These games would include the adult version of "Do or Drink". This game directs players to do acts that include spanking and removing of clothes. In addition to the drinking games, Erickson would show the juveniles pornographic movies and encourage them to masturbate. The masturbation would sometimes include Erickson and the juveniles masturbating each other. This was reported to occur after the juveniles were very intoxicated.

Evidence recovered includes text messages, videos, and Erickson's phone.

It was reported that the criminal offenses occurred at different locations both within and outside of York County. The criminal charges obtained by York County Sheriff's Office occurred at Erickson Lee's residence, which is located at 3400 Caroland Dr., Fort Mill, SC in the County of York. Erickson Lee was charged with the following offenses:

Criminal Sexual Conduct with a Minor 2nd degree 2023A4610201099
Criminal Sexual Conduct with a Minor 3rd degree 2023A4610201100
Assault & Battery 1st degree 2023A4610201101
Contributing to the Delinquency of Minors X 4
Unlawful Dissemination of Obscene Material to person under 18 years of age X 3

The following is a summary of the individual interviews.

Interview with [REDACTED] by Detective Kinnee 4/28/23

Det. Kinnee asked [REDACTED] about a photo and a note that he found on his car. [REDACTED] explained that he received a text message from a number that he did not initially recognize. The message said "windshield wipers". When [REDACTED] went outside, he found a photo of himself when he was 13 or 14 yrs. old and note on his vehicle. The note said "I'm watching you!". [REDACTED] was able to check the phone number associated with the text message. The phone number belonged to Chase Portello (During an interview with Mr. Lee's after he was in custody, he admitted that he sent the text message to [REDACTED] from Chase's phone).

Det. Kinnee discussed with [REDACTED] about the initial report at Morning Star Church. [REDACTED] stated that [REDACTED] came forward first. The first exposure to

something wrong was allowing the sharing of vapes. [REDACTED] first exposure to alcohol provided by Mr. Lee, was when he was 15 or 16. This occurred at Mr. Lee's parents' house in NC. [REDACTED] and Mr. Lee played the drinking game Do or Drink. [REDACTED] stated this game dares players to do things indicated on the games cards instead of taking a drink of alcohol. The cards at times would tell players to remove an article of clothing. [REDACTED] indicated that he and the others have been naked while playing the game. Det. Kinnee asked [REDACTED] if he has ever touched Mr. Lee's penis or has Mr. Lee ever touched his penis. [REDACTED] replied that he has not touched Mr. Lee, but once or twice Mr. Lee has asked him to touch him. [REDACTED] stated that there was a time when he and Mr. Lee were intoxicated and they masturbated themselves. This occurred on the bed in Mr. Lee's residence, while they were watching porn. [REDACTED] stated that he was 16 when this occurred. [REDACTED] stated that he knew Mr. Lee was in possession of videos of him nude, while they were drinking and playing drinking games. Additionally, [REDACTED] believes that there are videos of the other victims as well.

[REDACTED] stated that during his time with Mr. Lee, he gave him alcohol to many times to count.

[REDACTED] talked about a time when he and Mr. Lee used face time while they both masturbated. [REDACTED] denied that they could see each other from the camera angle. [REDACTED] talked about a time that Mr. Lee took pictures of him naked.

Det. Kinnee asked [REDACTED] about the text message he received from the unknown number. [REDACTED] stated that he did not bring his phone, because he still has a tracking app on his phone that is connected to Mr. Lee. [REDACTED] stated that the tracking is through find my iPhone. Det. Kinnee asked [REDACTED] what is the purpose of the tracking. [REDACTED] stated the reason is to make sure he is ok and for Mr. Lee to know where he is at.

[REDACTED] stated four months ago his parents found messages in his phone from Mr. Lee. His parents were not comfortable with the context of the messages and they went to the church to complain. Mr. Lee was subsequently removed from the program and Mr. Lee was told not to contact any of the juveniles. Shortly after this, [REDACTED] found a note on his vehicle from Mr. Lee. The note informed [REDACTED] that he was doing ok. [REDACTED] received a second note two or three weeks ago. This note was hand delivered by Chase Portello during a Youth Special Forces training at the church. Chase pulled [REDACTED] aside from the others and let him read the note from Mr. Lee. Chase would not let [REDACTED] keep the letter.

Interview with [REDACTED] by Detective Kinnee 4/28/23

[REDACTED] stated that he was 13 when Erickson started providing alcohol for him. This drinking occurred in the basement of Mr. Lee's parent's residence in Charlotte, NC. [REDACTED] was present on several occasions and he too drank alcohol provided by Mr. Lee.

█████ spoke about a time he was 13 and he went with Mr. Lee to Camp Lejeune to help him move out of the barracks. They were playing card games and drinking alcohol. At one point, Mr. Lee took █████ hand and placed it on his penis. Mr. Lee then grabbed █████ penis and they started to masturbate each other. █████ thought that he ejaculated, but does not believe Mr. Lee did. █████ did not remember coming in contact with the base security when he entered the base.

Shortly after leaving the military, Mr. Lee moved into an apartment on the property where █████ and his family lived. █████ stated that the drinking of alcohol became more frequent. Erickson would have some of the Young Special Forces juvenile members over to his residence for a meeting and he would provide them with alcohol. During these meetings, Erickson would encourage the intoxicated juveniles to watch pornography with him and play drinking games. The group of juveniles would include █████. While watching pornography, Erickson would encourage the juveniles to masturbate themselves or each other.

In total, █████ explained that mutual masturbation between him and Erickson occurred between 30 and 50 times when he was 14 to 15 years old. Warrant # 2023A4610201100 CSC w/minor 3rd degree.
During their time together, oral sex occurred 4 times.

1st time: On April 10/11, 2021 when █████ was 14 yrs. old, Erickson brought him to a Monster Truck Show in Columbia, SC. While staying the night at a Holiday Inn, Erickson gave █████ oral sex.

2nd time: On July/Aug. 2021 when █████ was 15 talked he was at property Doug Lee owned in Chester County. █████ was drinking around a campfire with Doug Lee and Erickson. Doug left and he and Erickson kept drinking. █████ was so drunk that Erickson had to carry him into a cabin. █████ believes on this night that they had oral sex.

3rd time: In December 2021 when █████ was 15 he was in the apartment at 3400 Caroland Dr., Fort Mill, SC. █████ and Erickson were drinking heavily and playing Irish Poker. Erickson was apologizing for an earlier argument. █████ stated that after drinking, they were sleeping in the bed and Erickson removed his boxer shorts. Erickson started masturbate █████ and then gave him oral sex. Warrant # 2023A4610201099 CSC w/minor 2nd degree.

4th time: On July 24th/25th 2022 █████ & Erickson took a trip to Washington DC to see the military aircraft hangar where Chase Portello worked. █████, Erickson, and Chase stayed together in an Air B & B in Arlington, VA. █████ explained that this was probably the drunkest he has ever been. This occurred on July 24TH & 25TH 2022. After drinking a large amount of alcohol, █████ passed out in a bed with Erickson. Erickson pulled his pants off. █████ remembered saying no, but Erickson continued to give him oral sex. It was after this, █████ decided to not hang out with Erickson anymore.

Interview with [REDACTED] by Detective Kinnee 5/1/23

[REDACTED] described the closeness of the group of 5 and they were part of the program from the start. [REDACTED] remembered the first time he went to Erickson's apartment to plan an event for YSF. He was 14 yrs. old and he remembers drinking until he got sick. He, [REDACTED] and Erickson were there. He remembers drink a drink called liquid marijuana and flaming Dr. Pepper. [REDACTED] talked about playing the "Do or Drink" game. This game would include nudity and acting out somewhat sexual acts involving body parts.

[REDACTED] talked about his interaction with Erickson. At times, he described it as kind of perverted and he disclosed that Erickson would send pictures of his penis to [REDACTED]

[REDACTED] described an incident where he was very intoxicated at Erickson's apartment. He was laying on Erickson's bed when he was 16 with Erickson and [REDACTED]. They were on the bed with their clothes off and Erickson put porn on the TV. They were all masturbating themselves, when Erickson grabbed [REDACTED]' hand and put it on his penis. Erickson then put his hand on [REDACTED] penis. After a couple of minutes, Erickson switched his hand to [REDACTED] penis. [REDACTED] stated that he would not have consented to this if he was not intoxicated.

[REDACTED] stated over the course of his time with Erickson, he drank alcohol provided by Erickson 8 to 12 times.

Interview with [REDACTED] by Sgt. Smith

On 4/28/23, Detective Sgt. A. Smith met with [REDACTED] at the York County Sheriff's Office for an interview.

[REDACTED] stated that he knew Erickson ever since Erickson became his youth leader at Morningside Church located in Fort Mill, SC. [REDACTED] stated that he was [REDACTED] was about 14 ½ years old.

[REDACTED] disclosed that he would attend camping trips with Youth Special Forces and during those trips Erickson would provide some of the juveniles' alcohol.

[REDACTED] recalled an incident during his second year in the YSF program. He stated that Erickson provided cherry-flavored vodka to him and other boys. He stated that they were at a "lock-in" at the church. It was on New Year's Eve and a big church service was being held at Morningside. Young males and females were in attendance at this event. [REDACTED] stated that Erickson supplied a big plastic water bottle (normal drinking bottle) that contained ice and a cherry flavored vodka. [REDACTED] stated that he and the other boys were in the bathroom, drinking the alcohol. [REDACTED] had stated that Erickson had provided the alcohol.

█████ stated that around the summer of his second year of being in YSF, he recalled that Erickson would provide vaping materials to him and the other boys. He stated that Erickson acted like one of them, and seemed to do things to fit in with the boys. █████ stated that Erickson would drug test him and the other boys. He stated that he and the other boys' vaped in front of Erickson and Erickson would vape in front of them. Erickson would tell them about a new vape flavor and provide it for the boys, inviting them to try it. Erickson would tell the boys that doing anything other than vaping and drinking alcohol was wrong. █████ stated that he was afraid to try other drugs. Erickson threatened to fire █████ from the program if he █████ did other drugs.

█████ talked about incidents that occurred at Erickson's apartment.

█████ stated that █████ would usually be at Erickson's apartment with █████. Sometimes █████ was also there. █████ stated that they would watch horror movies and rape documentaries together. He said that they would watch documentaries about Jeffrey Dahmer and John Wayne Gasey. █████ stated that when they would all hang out at Erickson's apartment, they would drink, vape, and play cards. █████ stated that they would play a card game called "Do this or Drink this." He stated that it was a drink or dare game. He stated that some of the dares would be, for example, a dare for him to give a hickey to the person next to him. █████ stated that the dares would progress to being dared to perform sex acts, take clothing off, and to do other perverted things. █████ stated that by this time, he viewed Erickson as "one of them." He said that sex acts took place. He stated that some of the dares would be to take a belly shot off of one of the boys in the group. He stated that some of the dares might be to seductively suck on someone else's finger or to give a lap dance to another boy. █████ stated that Erickson would give lap dances.

█████ recalled the incident (July 2022) previously reported by █████ where he, █████ Erickson and █████ were all laying on Erickson's bed, on their backs. He recalled that Erickson was playing a pornographic video. He recalled that in the movie, there was a white man and woman. The male was having vaginal sex with the female. █████ stated that they all were very drunk. Erickson reached over █████ and took his █████ hand to masturbate his own (Erickson's) bare penis. Warrant # 2023A4610201101 A&B 1st degree.

█████ stated that when Erickson would provide alcohol for him and the other boys, he █████ would drink around 14 - 15 shots of alcohol. █████ stated that he did not remember participating in oral sex during any of the times that he was hanging out with Erickson and the other boys. █████ did state that he █████ would be so intoxicated, he could not remember what occurred. █████ stated that Erickson would find ways to get him and the other boys to undress. Erickson would try to get █████ pants off. █████ stated that Erickson would show him and the other boys, random pornographic pictures in addition to the pornographic videos. Erickson would often talk about sex. █████ stated that Erickson sent nudes of himself to █████. █████ stated that Erickson would expose himself to the boys. He stated that on Snapchat, he, █████ and Erickson were all in a group chat together. He stated that in this Snapchat, nudes were sent, to include Erickson sending pictures of his penis and full nudes of himself.

█████ stated that Erickson had showed him and the other boys the series or videos "The Gauntlet." He stated that there were 50 levels, and he made it up to or through level 14. █████ stated that very graphic material was in these videos, to include bestiality. He recalled Erickson showing them a video of a man inserting a jar into his rectum.

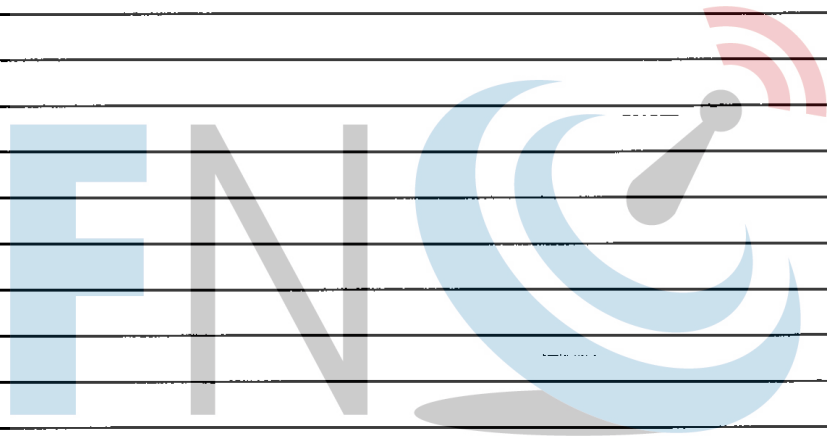

The affiant, who is a certified law enforcement officer assigned to the York County Sheriff's Office Criminal Investigation Division and has several years of experience, including criminal investigations, states the following facts to support probable cause to search for the items listed.

Detective Sgt. A. Smith was assigned to assist Detective Thomas Kinnee in his investigation involving allegations of sexual assaults that occurred during the last several years at the Defendant's residence. The juvenile Victims in this case reported that over the past few years, former church youth leader (Erickson Douglas Lee) had sexually assaulted them and showed them pornographic movies at Lee's residence located at 3400 Caroland Dr, Fort Mill, County of York, South Carolina.

The juvenile Victims stated that Lee would provide alcohol and vaping materials to them. The Victims stated that when they got very intoxicated, Lee would encourage them to remove their own clothing. At least one of the Victims stated that Lee would take photos and videos of them, sometimes without their clothes on and would send them nudes of himself. During the course of the investigation led by law enforcement, Det. Sgt. Amy Smith and Detective T. Kinnee met with these juvenile victims to obtain statements from them.

In investigations involving photographs and videos being taken of juveniles, at times, without their clothes on, it is reasonable to believe that these photographs and videos are likely to be found on the suspect's cell phone and / or on electronic devices that were within the care, custody and / or control of the Suspect, Lee. The affiant, who is a certified law enforcement officer assigned to the York County Sheriff's Office Criminal Investigation Division and has several years of experience, including criminal investigations, states the following facts to support probable cause to search for the items listed.

Detective Sgt. A. Smith was assigned to assist Detective Thomas Kinnee in his investigation involving allegations of sexual assaults that occurred during the last several years at the Defendant's residence. The juvenile Victims in this case reported that over the past few years, former church youth leader (Erickson Douglas Lee) had sexually assaulted them and showed them pornographic movies at Lee's residence located at 3400 Caroland Dr, Fort Mill, County of York, South Carolina.

The juvenile Victims stated that Lee would provide alcohol and vaping materials to them. The Victims stated that when they got very intoxicated, Lee would encourage them to remove their own clothing. At least one of the Victims stated that Lee would take photos and videos of them, sometimes without their clothes on and would send them nudes of himself. During the course of the investigation led by law enforcement, Det. Sgt. Amy Smith and Detective T. Kinnee met with these juvenile victims to obtain statements from them.

In investigations involving photographs and videos being taken of juveniles, at times, without their clothes on, it is reasonable to believe that these photographs and videos are likely to be found on the suspect's cell phone and / or on electronic devices that were within the care, custody and / or control of the Suspect, Lee. Smith is requesting permission to download Lee's cell phone and laptop computer. Lee's cell phone was seized by CMPD at the time of his arrest on 5/28/23, in Charlotte, NC.
