Nate stated that n ear y 2018 Er ckson began a program at the church ca ed the Young Spec a Forces. Er ckson p tched this program as a leadersh p school for young men to help them learn sk is and develop team building habits. A leged yin early 2020 Er ckson began taking at least four of these juven less and providing them a coholi, hosting parties, and performing sexual acts on them. Er ckson would a leged ying provide or along them a coholi, hosting parties, and performing sexual acts on them. Er ckson would along the juven less as well as host nucled rinking games with the young men. Er ckson would host these parties by teing parents that he wanted to take the juven less out to host a leadersh plexer sever sever a camping trip before taking the juven less to various locations both in side and outside of York County such as at the Morning Star Church, Lee's residence, campisites, and Myrtie Beach. Nate was informed that any thing of this nature that occurred outside of York County jurisdiction would also need a police report field with the appropriate agency. In January of 2023 Er ckson's Young Special Forces was dissolved by the church due to separate a legations made by Er ckon's mother regarding unrelated ssues. Since the dissolved the group Several of the young men have come forward to their parents about the alegations prompting parents to not fy the church, who then not field Nate. As much victim, parental, and suspect information as possible has been provided and screen shots of text messages and photos of letters written to Nate have been uploaded to Evidence.com

On April 26, 2023 Deputy Thompson took an initial report from Nate Degrandpre, who is the Safety Coordinator at Morning Star Church. Mr. Degrandpre reported that he received complaints from some of the church members regarding inappropriate behavior between a youth leader and their children. The children are juvenile males that belong to a program at the church called Youth Special Forces. The youth leader was identified as Erickson Lee. Deputy Thompson's report lists 4 juveniles currently between 16 & 18 yrs. old.

According to Mr. Degrandpre in early 2018 Erickson Lee began a program at the church called the Young Special Forces. Mr. Lee pitched this program as a leadership school for young men to help them learn skills and develop team building habits. In early 2020 Erickson began taking at least four of these juveniles and providing them alcohol, hosting parties, and performing sexual acts on them. Erickson would allegedly provide oral and digital stimulation to the juveniles, as well as host nude drinking games with the young men. Erickson would host these parties by telling parents that he wanted to take the juveniles out to host a leadership exercise or a camping trip before taking the juveniles to various locations both inside and outside of York County such as at the

Morning Star Church, Erickson's residence, camp sites, and Myrtle Beach. In January of 2023 Erickson was asked to discontinue his involvement with Young Special Forces.

On April 27, 2023 Detective Kinnee was assigned to investigate the reported allegations. In summary, the victims were interviewed by either Det. Kinnee or Sergeant Smith at the Moss Justice Center. The victims provided statements, which indicated Erickson committed acts of Criminal Sexual Conduct with Minors, Disseminated Obscene Material to minors and Contributed to the Delinquency of Minors. These criminal offenses occurred over the course of several years. Erickson regularly provided alcohol to the juveniles and allowed them to consume alcohol until they were sick or passed out. Erickson would motivate the juveniles to drink excessive amounts of alcohol by playing drinking games. These games would include the adult version of "Do or Drink". This game directs players to do acts that include spanking and removing of clothes. In addition to the drinking games, Erickson would show the juveniles pornographic movies and encourage them to masturbate. The masturbation would sometimes include Erickson and the juveniles masturbating each other. This was reported to occur after the juveniles were very intoxicated.


Evidence recovered includes text messages, videos, and Erickson's phone.

It was reported that the criminal offenses occurred at different locations both within and outside of York County. The criminal charges obtained by York County Sheriff's Office occurred at Erickson Lee's residence, which is located at 3400 Caroland Dr., Fort Mill, SC in the County of York. Erickson Lee was charged with the following offenses:

spoke about a time he was 13 and he went with Mr. Lee to Camp Lejeune to help him move out of the barracks. They were playing card games and drinking alcohol. At one point, Mr. Lee took hand and placed it on his penis. Mr. Lee then grabbed penis and they started to masturbate each other. It thought that he ejaculated, but does not believe Mr. Lee did. It did not remember coming in contact with the base security when he entered the base.
Shortly after leaving the military, Mr. Lee moved into an apartment on the property where and his family lived. stated that the drinking of alcohol became more frequent. Erickson would have some of the Young Special Forces juvenile members over to his residence for a meeting and he would provide them with alcohol. During these meetings, Erickson would encourage the intoxicated juveniles to watch pornography with him and play drinking games. The group of juveniles would include . While watching pornography, Erickson would encourage the juveniles to masturbate themselves or each other.
In total, explained that mutual masturbation between him and Erickson occurred between 30 and 50 times when he was 14 to 15 years old. Warrant # 2023A4610201100 CSC w/minor 3rd degree. During their time together, oral sex occurred 4 times.
1st time: On April 10/11, 2021 when was 14 yrs. old, Erickson brought him to a Monster Truck Show in Columbia, SC. While staying the night at a Holiday Inn, Erickson gave oral sex.
2nd time: On July/Aug. 2021 when was 15 talked he was at property Doug Lee owned in Chester County. was drinking around a campfire with Doug Lee and Erickson. Doug left and he and Erickson kept drinking. was so drunk that Erickson had to carry him into a cabin. believes on this night that they had oral sex.

It was after this, decided to not hang out with Erickson anymore.

described the closeness of the group of 5 and they were part of the program from the start. The remembered the first time he went to Erickson's apartment to plan an event for YSF. Talked about playing the "Do or Drink" game. This game would include nudity and acting out somewhat sexual acts involving body parts.

described an incident where he was very intoxicated at Erickson's apartment. He was laying on Erickson's bed when he was 16 with Erickson and . They were on the bed with their clothes off and Erickson put porn on the TV. They were all masturbating themselves, when Erickson grabbed 'hand and put it on his penis. Erickson then put his hand on penis. After a couple of minutes, Erickson switched his hand to penis. Stated that he would not have consented to this if he was not intoxicated.
stated over the course of his time with Erickson, he drank alcohol provided by Erickson 8 to 12 times.

On 4/28/23, Detective Sgt. A. Smith met with at the York County Sheriff's Office for an interview.
stated that he knew Erickson ever since Erickson became his youth leader at Morningside Church located in Fort Mill, SC. stated that he was sabout 14 ½ years old.
disclosed that he would attend camping trips with Youth Special Forces and during those trips Erickson would provide some of the juveniles' alcohol.
recalled an incident during his second year in the YSF program. He stated that Erickson provided cherry-flavored vodka to him and other boys. He stated that they were at a "lock-in" at the church. It was on New Year's Eve and a big church service was being held at Morningside. Young males and females were in attendance at this event. Stated that Erickson supplied a big plastic water bottle (normal drinking bottle) that contained ice and a cherry flavored vodka. Stated that he and the other boys were in the bathroom, drinking the alcohol.

stated that around the summer of his second year of being in YSF, he recalled that Erickson would provide vaping materials to him and the other boys. He stated that Erickson acted like one of them, and seemed to do did things to fit in with the boys. stated that Erickson would drug test him and the other boys. He stated that he and the other boys' vaped in front of Erickson and Erickson would vape in front of them. Erickson would tell them about a new vape flavor and provide it for the boys, inviting them to try it. Erickson would tell the boys that doing anything other than vaping and drinking alcohol was wrong. stated that he was afraid to try other drugs. Erickson threatened to fire from the program if he did other drugs. stated that would usually be at Erickson's apartment. Sometimes was also there. stated that they would watch horror movies and rape documentaries together. He said that they would watch documentaries about Jeffrey Dahmer and John Wayne Gasey. stated that when they would all hang out at Erickson's apartment, they would drink, vape, and play cards. stated that it was a drink or dare game. Erickson would try to get pants off. stated that Erickson would show him and the other boys, random pornographic pictures in addition to the pornographic videos. Erickson would often talk about sex. stated that Erickson sent nudes of himself to stated that Erickson would expose himself to the boys. He stated that on Snapchat, he, and Erickson were all in a group chat together. He stated that in this Snapchat, nudes were sent, to include Erickson sending pictures of his penis and full nudes of himself.

stated that Erickson had showed him and the other boys the series or videos "The Gauntlet." He stated that there were 50 levels, and he made it up to or through level 14.

stated that very graphic material was in these videos, to include bestiality. He recalled Erickson showing them a video of a man inserting a jar into his rectum.


