**VERIFIED COMPLAINT** 

(ACTION ON PROMISSORY NOTE AND GUARANTIES)

(NON-JURY)

The Plaintiffs, Comtex, Inc. ("Comtex") and Richard A. Lackey ("Mr. Lackey") (collectively "Plaintiffs"), complaining of the defendants herein, would show unto this Court as follows:

- 1. Comtex is a corporation duly organized and existing under the laws of the State of Delaware and is authorized to transact business in South Carolina.
  - 2. Mr. Lackey is a citizen and resident of the County of Greenville, State of South Carolina.
- 3. Upon information and belief, Exodus Aircraft, LLC ("Exodus") is a Delaware limited liability company with its principal place of business in in the County of Spartanburg, State of South Carolina.
- 4. Upon information and belief, Frank G. Rogers ("Rogers") is a citizen and resident of the County of Greenville, State of South Carolina.
- 5. Upon information and belief, Joshua Kimbrell ("Kimbrell") is a citizen and resident of the County of Spartanburg, State of South Carolina.
- 6. This Court has jurisdiction over the parties and the subject matter of this action, and venue is proper in Spartanburg County.

- 7. On or about October 26, 2022, Exodus, for valuable consideration, made, executed, and delivered a certain Installment Note, payable to Comtex or Mr. Lackey, in the original principal amount of Two Hundred Fifty Thousand and No/100 Dollars (\$250,000.00) together with interest and other charges as provided therein (the "Note"). A true and accurate copy of the Note is attached hereto and incorporated herein as Exhibit A.
- 8. In order to induce Comtex and Mr. Lackey to enter into the aforesaid transaction evidenced by the Note, and to further secure the same, the defendants Rogers and Kimbrell (collectively the "Guarantors"), for consideration, executed written guarantees dated October 26, 2022 whereby the said Guarantors absolutely, unconditionally, and irrevocably guaranteed to Comtex and Mr. Lackey the full and prompt payment of all obligations of Exodus under the Note. See Ex. A, ¶¶ 5–6.
- 9. On or about October 26, 2023, Exodus, for valuable consideration, made, executed, and delivered a certain Installment Note Extension, payable to Comtex or Mr. Lackey, in the original principal amount of Two Hundred Fifty Thousand and No/100 (\$250,000.00) together with interest and other charged as provided therein (the "Extension Note"). A true and accurate copy of the Extension Note is attached hereto and incorporated herein as Exhibit B.
- 10. In order to induce Comtex and Mr. Lackey to enter into the aforesaid transaction evidenced by the Extension Note, and to further secure the same, the defendants Rogers and Kimbrell (collectively the "Guarantors"), for consideration, executed written guarantees dated October 26, 2023 whereby the said Guarantors absolutely, unconditionally, and irrevocably guaranteed to Comtex and Mr. Lackey the full and prompt payment of all obligations of Exodus under the Extension Note. *See* Ex. B, ¶¶ 5–6.

- 11. The obligations under the Note and subsequent Extension Note are in default for, among other reasons, Exodus' failure to make payments when due.
- 12. As a result of the aforesaid defaults, Comtex and Mr. Lackey have exercised their rights to declare the entire balance under the Note and Extension Note immediately due and payable in full.
- 13. There is now due and owing under the Note and Extension Note—as of August 6, 2025, and exclusive of attorneys' fees, costs of collection, and additional interest since that date—the sum of \$255,303.32, which represents: (1) unpaid principal in the amount of \$250,000.00 and (2) accrued and unpaid interest in the amount of \$5,303.32.
- 14. Plaintiffs mailed a loan default notice to Exodus, Rogers, and Kimbrell on June 26, 2025.

  A true and accurate copy of the notice is attached hereto and incorporated herein as Exhibit C.
- 15. The loan documents provide that the Guarantors would pay all costs and expenses of collection including, but not limited to, reasonable attorneys' fees.
- 16. Comtex and Mr. Lackey are therefore entitled to judgment against Exodus and the Guarantors, jointly and severally, in the aggregate amount of \$255,303.32, plus additional interest and other amounts properly chargeable to the aforesaid loan, including without limitation, reasonable attorneys' fees and the costs of this action.

WHEREFORE, Comtex and Mr. Lackey pray for judgment against Exodus and the Guarantors, jointly and severally, in the amount of \$255,303.32, plus additional interest after August 6, 2025, together with reasonable attorneys' fees and the costs of this action, and for such other and further relief in Plaintiffs' favor as the Court deems just and proper.
