Per SC 23-23-85 Standard - Internal Affairs: All substantiated complaints must be reported to the South Carolina Criminal Justice Academy via designated online forms. Substantiated complaints include those offenses where an officer was suspended, or meets any of the other criteria as stated in South Carolina Code of Regulations 37-025.

On July 18, 2025, the Kershaw County Sheriff's Office received notification from the State Law Enforcement Division regarding a complaint that had been forwarded to them concerning Officer Jorien Watson of this agency. [REDACTED] a private investigator, forwarded a written affidavit that he obtained from [REDACTED]. [REDACTED] wrote in her statement that she had been involved in a romantic relationship with Jorien Watson. [REDACTED] stated that she had witnessed Deputy Watson operate his county-issued patrol vehicle after using alcohol. [REDACTED] stated that she knew this to be factual as she had brought alcohol to his residence for them to consume, and that after consuming the alcohol, he then drove away in his county-issued vehicle.

After receiving the complaint, this agency contacted [REDACTED] and scheduled an interview with her at 2:00 PM on July 18, 2025. [REDACTED] arrived at the office and was escorted to an interview room. [REDACTED] was interviewed and confirmed that the statement was hers. She also provided details of Deputy Watson consuming alcohol and driving his county-issued car.

Deputy Watson was ordered to report to the office before his tour of duty began. Deputy Watson was taken to an interview room with Captain Miller (Investigations / IA) and Captain West (Patrol). Once in the interview room, Deputy Watson was notified of the complaint against him and reminded of the policy on untruthfulness. Deputy Watson advised that he understood. Deputy Watson was then asked about using alcohol and then operating, and he admitted that he had in the past. Deputy Watson was asked if there is any alcohol in his vehicle and he stated no and handed over the keys. Captain Miller and Lt. Taylor then searched the vehicle and did find a bag containing empty cans of alcohol and an empty bottle of vodka. Those items were collected.

Deputy Watson was terminated for violating of the Kershaw County Sheriff's Office policy 1000.7 on alcohol use with a county vehicle.

There is a current open investigation with SLED on an unrelated incident. SLED cleared Jorien Watson to return to work, and Captain Miller (KCSO IA) was under the impression that the matter was resolved, but it is currently still pending closure by SLED. At the request of Sheriff Boan, SLED also has an open threat assessment open for Jorien Watson as well. The KCSO does not have an open internal/criminal investigation on Jorien Watson.
