ASSAULT 2ND

UNLAWFUL CONDUCT TOWARDS CHILD

ON 10/10/2025, I, DET. BAKER RESPONDED TO 713 S. PARSONAGE ST. IN BENNETTSVILLE SC, IN REFERENCE TO AN ASSAULT. UPON MY ARRIVAL, I WAS MET AT THE DOORWAY BY A CROWD WHO ADVISED THAT A FEMALE SUBJECT HAD SPRAYED SOME TYPE OF CHEMICAL IN THE FACE OF DEPARTMENT OF SOCIAL SERVICES WORKER [REDACTED]. UPON ENTERING THE BUILDING, I OBSERVED THE VICTIM, [REDACTED], SITTING ON THE FLOOR. I RECOGNIZED A STRONG ODOR, CONSISTENT WITH OC SPRAY WAS PRESENT THROUGHOUT THE AREA. SEVERAL INDIVIDUALS WERE RENDERING AID TO MS. [REDACTED], AND SHE WAS LATER MOVED OUTSIDE FOR DECONTAMINATION WHILE AWAITING THE ARRIVAL OF EMS. WHILE ON SCENE, I OBTAINED THE NAME OF THE SUSPECT AS SHALANDA MCCLAIN. WITNESSES REPORTED THAT EARLIER IN THE DAY, MS. MCCLAIN HAD CALLED THE OFFICE INQUIRING ABOUT HER SNAP CASE AND WAS ADVISED THAT NO INFORMATION WAS AVAILABLE AT THAT TIME. A SHORT TIME LATER, MS. MCCLAIN ARRIVED AT THE OFFICE WITH HER JUVENILE CHILD. AS [REDACTED] ATTEMPTED TO PROVIDE SERVICES TO HER, MS. MCCLAIN SPRAYED HER IN THE FACE WITH A CHEMICAL AGENT. MS. MCCLAIN THEN FLED THE SCENE WITH HER JUVENILE CHILD. OFFICERS OF THE BENNETTSVILLE POLICE DEPARTMENT RESPONDED TO THE LISTED ADDRESS FOR SHALANDA MCCLAIN, [REDACTED], BENNETTSVILLE, SC, BUT WERE INITIALLY UNABLE TO LOCATE HER. A SHORT TIME LATER, MS. MCCLAIN RETURNED TO THE ADDRESS, WHERE SHE WAS ARRESTED WITHOUT INCIDENT AND TRANSPORTED TO THE MARLBORO COUNTY DETENTION CENTER.
