That on December 4, 2025 in the city/county of Anderson, one Ashaley Chrishton Boatwright did knowingly sell, manufacture, deliver or bring into this State and/or possess ten pounds or more, but less than one hundred pounds of Marijuana, a Schedule I Controlled Substance, without authority to do so. This incident took place at 124 Commons Parkway in the Anderson, SC city limits. On this date, a search warrant was executed inside a business owned by defendant and Jesse Turner called The Abduction Dispensary & 420 Cafe. Defendant was then found to be in constructive possession of various cannabis products to include raw plant material, wax, extracts, and concentrates in excess of 10 pounds located inside the business. Based on affiant's training and experience, the products which were seized are identified as Marijuana/THC, THC waxes, THC extracts, and THC concentrates that contain Delta 9 THC concentration levels greater than 0,3 percent. 
ACKNOWLEDGEMENT BY DEFENDANT

It has been explained to me that if I fail to appear before the court as required, a warrant for my arrest will be issued.


